HHS Grants Bolster Health Care and Public Health Disaster Preparedness

The Department of Health and Human Services (HHS) recently awarded more than \$971 million to continue improving preparedness and health outcomes for a wide range of public health threats within every state, eight US territories, and four of the nation's largest metropolitan areas.

The funding awards included a total of approximately \$352 million awarded for the Hospital Preparedness Program (HPP) cooperative agreement and more than \$619 million awarded for the Public Health Emergency Preparedness (PHEP) cooperative agreement.

For the first time, the HPP and PHEP funds are being awarded jointly, encouraging cooperation between the nation's health care and public health systems. This change follows a year-long effort by the HHS Office of the Assistant Secretary for Preparedness and Response and the Centers for Disease Control and Prevention to align the two federal preparedness programs.

State Planning Grant Initiative

The Aging Network's Volunteer Collaborative is pleased to announce a planning grant opportunity for four state agencies. The four grants of up to \$25,000 will be awarded to four State Agencies on Aging for developing a State Volunteer Engagement Plan. The purpose of the State Volunteer Engagement Plan (Plan) is to help the Aging Network's Volunteer Collaborative meet its goal of doubling the current number of volunteers now serving the aging network.

The Plan should be a new initiative and not one created by the federal government which is now being implemented at the state. Additionally, it should be statewide and not limited to "pilot areas," although it is acceptable if an initiative is being currently implemented in one geographic area and the plan is to take it statewide. Also, special consideration will be given to State Volunteer Engagement Plans which seek to have a collaborative effort with the State Service Commission and the Corporation for National and Community Service State Office. In addition, the State Volunteer Engagement Plan design and strategy must meet the following minimum requirements:

- Produce a measurable impact on up to three (3) priority state needs for improved or expanded aging services to low income or vulnerable older adults:
- Include a plan for developing a variety of engagement opportunities including intensive (12 15 hours per week), sustained over time (6 12 months), as well as new opportunities for more traditional episodic or less intensive (2 5 hours per month or quarter) volunteer opportunities;

- Demonstrate focus on Boomers as volunteers. Note: special consideration will be given to minority/ethnic community recruitment;
- Show how implementation of the plan over time will result in significantly increasing the current number of volunteers working on the identified impact area(s).
- Include an evaluation plan and strategy for measuring impact and results on agencies, volunteers and impact areas;
- Include a plan for sustaining the initiative;

New Funding Opportunity to Help States Continue Their Work to Implement ACA

This new funding opportunity will provide states with 10 additional opportunities to apply for funding to establish a state-based exchange, state partnership exchange, or to prepare state systems for a federally facilitated exchange. To date, 34 states and the District of Columbia have received approximately \$850 million in Exchange Establishment Level One and Level

Two cooperative agreements to fund their progress toward building exchanges. States can apply for exchange establishment cooperative agreements through the end of 2014. These funds are available for states to use beyond 2014 as they continue to work on their exchanges. This ensures that states have the support and time necessary to build the best exchange for their residents.

CMS Proposes Primary Care Pay Raise for 2013

On July 6th, the Centers for Medicare & Medicaid Services (CMS) issued a proposed rule that would increase payments to family physicians by approximately 7 percent and other practitioners providing primary care services between 3 and 5 percent. The increase in payment to family practitioners is part of the proposed rule that would update payment policies and rates under the Medicare Physician Fee Schedule (MPFS) for calendar year (CY) 2013. Under the MPFS, Medicare pays more than 1 million physicians and non-physician practitioners that provide vital health services to Medicare beneficiaries.

The proposed rule would also continue the careful implementation of the physician value-based payment modifier (Value Modifier) that was included in

the Affordable Care Act by providing choices to physicians regarding how to participate. The Value Modifier adjusts payments to individual physicians or groups of physicians based on the quality of care furnished to Medicare beneficiaries compared to costs. The law allows CMS to phase in the Value Modifier over three years from CY 2015 to CY 2017.

The proposed rule will appear in the July 30, 2012 Federal Register. CMS will accept comments on the proposed rule until September 4, 2012, and will respond to them in a final rule to be issued by November 1, 2012.

Organ Donation - Any Age Is the Right Age to Give, and Receive

The need for organ donation is real. If you think you are too old to be an organ, eye and tissue donor, think again! Any age is the right age to sign up. Because we are living longer, healthier lives than ever before, more of us can be organ, eye, and tissue donors and recipients ... into our 50s, 60s, 70s, even into our 80s and 90s. In 2011, 60% of all individuals who received organ transplants were over 50, yet only 32% of all organ donors were over the age of 50.

FDA Proposes Unique Device Identification System for Medical Devices

Last week, in response to requirements in legislation that passed Congress with broad bipartisan support, the US Food and Drug Administration (FDA) proposed that most medical devices distributed in the United States carry a unique device identifier, or UDI.

A UDI system has the potential to improve the quality of information in medical device adverse events reports, which will help the FDA identify product problems more quickly, better target recalls and improve patient safety. The FDA has worked closely with industry, the clinical community and patient and consumer groups and conducted four pilot studies in the development of this proposed rule. The FDA is seeking comment on the proposal for 120 days.
