# OCCUPATIONAL EMPLOYMENT AND WAGES IN SAN LUIS OBISPO-PASO ROBLES, MAY 2011

Workers in the San Luis Obispo-Paso Robles Metropolitan Statistical Area had an average (mean) hourly wage of \$21.57 in May 2011, about 1 percent below the nationwide average of \$21.74, according to the U.S. Bureau of Labor Statistics. Regional Commissioner Richard J. Holden noted that, after testing for statistical significance, wages in the local area were significantly higher than their respective national averages in 9 of the 22 major occupational groups, including protective service, construction and extraction, and healthcare practitioners and technical. Five groups had significantly lower wages than their respective national averages, including legal, computer and mathematical, and management.

When compared to the nationwide distribution, local employment was more highly concentrated in 4 of the 22 occupational groups, including food preparation and serving related, and sales and related. Conversely, nine groups had employment shares significantly below their national representation, including transportation and material moving, production, and business and financial operations. One occupational group—food preparation and serving related—was chosen to illustrate the diversity of data available for any of the 22 major occupational categories. San Luis Obispo-Paso Robles had 10,980 jobs in food preparation and serving related, accounting for 11.1 percent of local area employment, significantly higher than the 8.7-percent share nationally. The average hourly wage for this occupational group locally was \$10.30, compared to the national wage of \$10.30.

With employment of 2,500, waiters and waitresses was the largest occupation within the food preparation and serving related group, followed by combined food preparation and serving workers, including fast food (1,680) and restaurant cooks (1,060). Among the higher paying jobs were chefs and head cooks, and first-line supervisors of food preparation and serving workers, with mean hourly wages of \$23.35 and \$14.16, respectively. At the lower end of the wage scale were dishwashers (\$8.94) and cafeteria, food concession, and coffee shop counter attendants (\$9.17). Location quotients allow us to explore the occupational make-up of a metropolitan area by comparing the composition of jobs in an area relative to the national average. (See table 1.) For example, a location quotient of 2.0 indicates that an occupation accounts for twice the share of employment in the area than it does nationally. In the San Luis Obispo-Paso Robles Metropolitan Statistical Area, above average concentrations of employment were found in many of the occupations within the food preparation and serving related group. For instance, dining room and cafeteria attendants and bartender helpers were employed at 2.3 times the national rate in San Luis Obispo, and fast food cooks, at 1.9 times the U.S. average. On the other hand, combined food preparation and serving workers, including fast food had a location quotient of 0.8 in San Luis Obispo, indicating that this particular occupation's local and national employment shares were similar.

These statistics are from the Occupational Employment Statistics (OES) survey, a federal-state cooperative program between BLS and State Workforce Agencies, in this case, the California Employment Development Department. The OES survey provides estimates of employment and hourly and annual wages for wage and salary workers in 22 major occupational groups and nearly 800 detailed occupations for the nation, states, metropolitan statistical areas, metropolitan divisions, and nonmetropolitan areas.

OES wage and employment data for the 22 major occupational groups in the San Luis Obispo Metropolitan Statistical Area were compared to their respective national averages based on statistical significance testing. Only those occupations with wages or employment shares above or below the national wage or share after testing for significance at the 90-percent confidence level meet the criteria.

NOTE: A value that is statistically different from another does not necessarily mean that the difference has economic or practical significance. Statistical significance is concerned with the ability to make confident statements about a universe based on a sample. It is entirely possible that a large difference between two values is not significantly different statistically, while a small difference is, since both the size and heterogeneity of the sample affect the relative error of the data being tested.

#### **Technical Note**

The Occupational Employment Statistics (OES) survey is a semiannual mail survey measuring occupational employment and wage rates for wage and salary workers in nonfarm establishments in the United States. Guam, Puerto Rico, and the Virgin Islands also are surveyed, but their data are not included in the national estimates. OES estimates are constructed from a sample of about 1.2 million establishments. Forms are mailed to approximately 200,000 establishments in May and November of each year for a 3-year period. The nationwide response rate for the May 2011 survey was 77.3 percent based on establishments and 73.3 percent based on employment. May 2011 estimates are based on responses from six semiannual panels collected over a 3-year period: May 2011, November 2010, May 2010, November 2009, May 2009, and November 2008. The sample in the San Luis Obispo-Paso Robles Metropolitan Statistical Area included 1,525 establishments with a response rate of 83 percent. The May 2011 OES estimates mark the first set of estimates based in part on data collected using the 2010 Standard Occupational Classification (SOC) system. Nearly all the occupations in this release are 2010 SOC occupations; however, some are not. The May 2012 OES data will reflect the full set of detailed occupations in the 2010 SOC. <sup>[4]</sup> Annual wages have been calculated by multiplying the hourly mean wage by a 'year-round, full-time' hours figure of 2,080 hours; for those occupations where there is not an hourly mean wage published, the annual wage has been directly calculated from the reported survey data.
