may have about the request.

invited them to the table to answer Commissioners' questions.

Chair Bauerly recognized Vice Chair Hunter who

MOVED to suspend the rules on the timely submission of agenda documents in order to consider the late submission of Agenda Document Nos. 11-38-A and 11-38-B.

The motion carried on a vote of 6-0 with Commissioners

Bauerly, Hunter, McGahn, Petersen, Walther, and Weintraub voting

affirmatively for the decision.

Chair Bauerly recognized Mr. David Adkins of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to Mr. Colbert's plans to establish and operate a political committee (the Colbert Federal Election Commission Minutes of an Open Meeting June 30, 2011

Super PAC), and whether that PAC would be in receipt of reportable in-kind contributions from Viacom if the Viacom show, the Colbert Show, covers and provides to the PAC advertisements and administrative support. Mr. Adkins summarized the issues in each of the three drafts which reach the same conclusions and the issues which reach different conclusions.

Chair Bauerly noted that this request presents the relatively novel issue of how the press exemption applies to coverage of a political committee that will provide an on-air premise for discussing campaign finance rules and other aspects of American politics.

Mr. Trevor Potter, the requestor's counsel, and Mr. Colbert, the requestor, participated in the discussion which followed.

Chair Bauerly recognized Commissioner McGahn who

MOVED to approve, with respect to Draft A as set forth in Agenda Document No. 11-38, question 1 as set forth on pages 6-7 and question 3, as set forth on page 15.
