Chair Caroline C. Hunter welcomed all of the children to the Commission's "Bring Our Daughters and Sons to Work Day." With the assistance of the children, she called the Federal Election Commission to order in an open meeting at 10:04 A.M. on Thursday, April 26, 2012 with a quorum present.

I. CORRECTION AND APPROVAL OF MINUTES

the decision.

Chair Hunter recognized Vice Chair Weintraub who

MOVED to waive the rules on the timely submission of agenda documents so that the Commission may consider Agenda Document Nos. 12-29, 12-22-B, 12-22-C, 12-24-B, and 12-27.

The motion carried on a vote of 5-0 with Commissioners Bauerly,

Hunter, McGahn, Petersen and Weintraub voting affirmatively for the

decision. Commissioner Walther did not vote.

II. DRAFT ADVISORY OPINION 2012-12

Dunkin' Brands, Inc. by William H. Minor, Esq.

Agenda Document No. 12-25

Chair Hunter noted that Mr. Minor, the requestor's counsel, was available to answer Commissioners' questions. She also welcomed Natalie and Georgia, Mr. Minor's daughters, to the Commission.

Chair Hunter recognized Mr. Tony Buckley of the General Counsel's

Office who presented the draft advisory opinion concerning the application
of the Federal Election Campaign Act of 1971, as amended, and

Commission regulations to Dunkin' Brands, Inc.' separate segregated
fund's proposal to solicit and accept contributions from its non-corporate
franchisees/licensees, as well as from the executive and administrative
personnel of Dunkin' Brands' corporate franchisees/licensees.

Chair Hunter recognized Vice Chair Weintraub who

MOVED to approve the answer to Dunkin' Brands, Inc. as set forth in Agenda Document No. 12-25, Draft Advisory Opinion 2012-12.

the decision.

III. DRAFT ADVISORY OPINION 2012-08

Repledge by Eric M. Zolt

Agenda Document No. 12-21

Agenda Document No. 12-21-A (Draft B)

(Held over from the meeting of April 12, 2012)

Chair Hunter noted that Professor Zolt, the requestor's representative, was available via telephone to answer Commissioners' questions.

Chair Hunter recognized Mr. Theodore Lutz of the General Counsel's

Office who presented the draft advisory opinion concerning the application
of the Federal Election Campaign Act of 1971, as amended, and

Commission regulations to Repledge's proposal to establish a Web-based
platform that would allow individuals to remove pledged funds in equal
amounts from opposing candidates for Federal office and, instead, to
donate their funds to charitable organizations. Repledge asked a series of
questions relating to its proposal. Mr. Lutz summarized the conclusions
reached in both drafts.

Professor Zolt participated in the discussion which followed.

Chair Hunter noted that Mr. David Urban and Mr. John Simms, the requestor's representatives, were available to answer Commissioners' questions.

Chair Hunter recognized Mr. Joshua Blume of the General Counsel's

Office who presented the draft advisory opinion concerning the application
of the Federal Election Campaign Act of 1971, as amended, and

Commission regulations to Points for Politics, LLC's proposal to offer a
patented system to individuals and political committees that converts

points that are awarded by corporations to individual consumers as
incentives to purchase the corporation's goods or services (such as
frequent flyer miles) into monetary equivalents that those individuals could
then contribute to political committees.

Discussion followed.

Chair Hunter recognized Vice Chair Weintraub who

MOVED to approve the draft answer in Advisory Opinion 2012-09 as set forth in Agenda Document No. 12-29.

The motion carried on a vote of 5-1 with Commissioners Bauerly,

opinion concerning the application of the Federal Election Campaign

Act of 1971, as amended, and Commission regulations to Greenberg

Quinlan Rosner Research, Inc.'s proposal. Ms. Heiden summarized the

conclusions reached in Revised Draft D and Draft E.

Mr. Sandler participated in the discussion which followed.

Chair Hunter recognized Commissioner Petersen who

MOVED to approve Draft E with the following changes:

- 1. On Page 4, Lines 9 11: beginning on Line 9, strike the remainder of the sentence after "surveys" and replace it with "made on behalf of Federal candidates, their authorized committees, or other Federal political committees that refer only to candidates for Federal office."
- 2. On Page 7, Line 5: strike the language "Federal candidates" and replace it with "Federal candidates, their authorized committees, or other Federal political committees that refer only to candidates for Federal office."
- 3. Make any technical and conforming changes.

Discussion resumed.

The motion carried on a vote of 5-1 with Commissioners Bauerly,

Hunter, McGahn, Petersen and Walther voting affirmatively for the decision.

Commissioner Weintraub dissented.

activities. Mr. Stipanovic summarized the conclusions reached in the three

drafts.

Chair Hunter recognized Commissioner Petersen who

MOVED to approve Draft C of Draft Advisory Opinion 2012-11 as set forth in Agenda Document No. 12-24-B.

The motion failed on a vote of 3-3 with Commissioners Hunter,

McGahn, and Petersen voting affirmatively for the motion. Commissioners

Bauerly, Walther and Weintraub dissented.

Chair Hunter recognized Vice Chair Weintraub who

MOVED to approve Draft B as set forth in Agenda Document No. 12-24-A.

The motion failed on a vote of 3-3 with Commissioners Bauerly,

Walther and Weintraub voting affirmatively for the motion. Commissioners

Hunter, McGahn and Petersen dissented.

Chair Hunter directed the Office of General Counsel to prepare a draft response which includes answers to those questions on which the Commissioners agree and circulate it on a tally vote basis.

VII. DRAFT ADVISORY OPINION 2012-13

Physician Hospitals of America by Edward M. Shack, Esq.

Agenda Document No. 12-26

Chair Hunter recognized Mr. Tony Buckley of the General
Counsel's Office who presented the draft advisory opinion concerning
the application of the Federal Election Campaign Act of 1971, as
amended, and Commission regulations to Physician Hospitals of
America's (PHA) request. PHA asks whether the involvement of its
member hospitals and their owners who are enrolled in government
sponsored healthcare programs (such as Medicare and Medicaid)
causes them to become federal contractors who would be prohibited
from making contributions to independent expenditure-only political
committees.

Chair Hunter recognized Vice Chair Weintraub who

MOVED to approve Draft Advisory Opinion 2012-13 as set forth in Agenda Document No. 12-26.

The motion carried on a vote of 6-0 with Commissioners Bauerly,

Hunter, McGahn, Petersen, Walther and Weintraub voting affirmatively for
the decision.

Commission regulations to Mr. McCutcheon's request to make aggregated
contributions to Federal candidates totaling \$54,400 during the 2011-2012
election cycle.

Mr. Hoersting and Mr. Backer participated in the discussion which followed.

Chair Hunter recognized Commissioner Petersen who

MOVED to approve Draft Advisory Opinion 2012-14 as set forth in Agenda Document No. 12-27.

The motion carried on a vote of 6-0 with Commissioners Bauerly,

Hunter, McGahn, Petersen, Walther and Weintraub voting affirmatively for
the decision.

Chair Hunter noted that Item IX (Draft Advisory Opinion 2012-07) would be held over to the next meeting.

The meeting recessed at 11:25 A.M. and reconvened at 11:42 A.M. with a quorum present.
