Committee. Ms. Selinkoff stated that the Commission received supplemental material from the requestor after the April 12, 2012 meeting and summarized the conclusions reached in the three drafts.

She noted that, after the Commission votes on the drafts before it today, the Office of General Counsel will prepare a draft response which includes answers to those questions on which the Commissioners agree and circulate it on a tally vote basis.
