

Federal Law Enforcement Training Accreditation Board Board Meeting July 12, 2012 Glynco, Georgia

I. Welcoming Remarks and General Announcements

Chairperson Donald Webb called the meeting to order at 9:00 a.m. He welcomed all attendees and asked everyone to stand for the presentation of the colors by the CBP Field Operations Academy Honor Guard. FLETA Board Member Commander Paul Baker, USCG, led the meeting attendees in reciting the Pledge of Allegiance.

Executive Secretary, Gary Mitchell, called the roll and reported 15 members were present, which constituted a quorum (attendance sheet attached).

Mr. Webb recognized the new FLETA Board officers who will hold terms for the next two years. He will continue as the Board Chairperson, 1st Vice Chairperson will be Ron Ward, 2nd Vice Chairperson will be Angela Hrdlicka, and Parliamentarian will be Brian Peters.

Mr. Mitchell then administered the Oath of Office to the new officers.

Mr. Webb recognized one new Board member, Michael Hillyard, an independent consultant filling the Accrediting Body seat.

Mr. Webb also recognized Board members Paul Baker and Tim Danahey who will be leaving the Board, presenting them with Certificates of Appreciation.

II. Board Review Committee Reports and Accreditation Awards

The Board met on Wednesday, July 11th, and conducted reviews of the following agencies:

Following the Board Review Committees, the FLETA Board met in Executive Session Wednesday afternoon and reviewed each application for accreditation or reaccreditation. The Board approved each application for accreditation/reaccreditation.

<u>Reaccreditation – USSS – Uniformed Division Training Course</u> – Board Member Brian Peters reported the results of the U.S. Secret Service Uniformed Division Training Course (UDTC) review. Mr. Peters gave a brief overview of the course and announced the Board approved the UDTC for reaccreditation.

Mr. Keith Hill, Assistant Director, Human Resources and Training, accepted the certificate on behalf of USSS Director Mark Sullivan, thanking Accreditation Manager Kim Canitz and Special Agent in Charge Percy Howard, noting the reaccreditation award validates their hard work.

<u>Initial Accreditation – CBP/BP – Physical Instructor Training Program</u> – Board Member Patrick Corcoran reported the results of the Border Patrol Academy Physical Instructor Training Program (PITP) review. Mr. Corcoran gave a brief overview of the course and announced the Board approved the PITP for its initial accreditation.

On behalf of Chief Correa and the Border Patrol Academy, Martin Cosio, Training Operations Supervisor for the Basic Physical Techniques Department, CBP Border Patrol Academy, accepted the accreditation certificate. He thanked the accreditation team "for all the work to get us to this point".

<u>Initial Accreditation – TIGTA – Special Agent Advanced Training Program</u> – Board Member Theresa Stoop reported the results of the TIGTA Special Agent Advanced Training Program (SAATP) review. Ms. Stoop recognized the assessment team for the quality of the assessment report. She then reviewed the program, noting the passion and knowledge of the TIGTA team, and announced the Board approved the SAATP for its initial accreditation.

Assistant Inspector General for Investigations Michael Delgado accepted the certificate of accreditation, thanking the TIGTA team and noting accreditation gives the training ultimate credibility. "It makes sure our training remains relevant in the future", he commented.

<u>Initial Accreditation – FBI – Instructor Development Course</u> – Board Member Michael Novak reported the results of the FBI Instructor Development Course (IDC) review. He recognized the assessment team, noting the assessment was very comprehensive, and announced the Board approved the IDC for its initial accreditation.

Owen Harris, Assistant Director, Training Division, accepted the accreditation certificate on behalf of Director Mueller and the Training Division. Mr. Harris thanked the FLETA

Board and the FBI staff for their hard work, "The FLETA Standards serve as the foundation for our work at the Academy as we continue to improve, plan, and move towards the future".

<u>Initial Accreditation – USCG – Boarding Team Member Course</u> – Board Member Nicholas Trotta reported the results of the U.S. Coast Guard Boarding Team Member Course (BTMC) review. He gave a brief overview of the course and announced the Board approved the IDC for its initial accreditation.

Commander Paul Baker accepted the program certificate on behalf of Rear Admiral Mehling, thanking the Board and the staff at the Maritime Law Enforcement Academy for their hard work.

<u>Reaccreditation – USCG – Basic Boarding Officer Course</u> – Board Member Timothy Danahey reported the results of the U.S. Coast Guard Basic Boarding Officer Course (BBOC) review. Mr. Danahey gave a brief overview of the course and announced the Board approved the BBOC for reaccreditation.

Commander Paul Baker accepted the program certificate and thanked the assessment team. He noted this course is one of the Coast Guard's kingpin courses and said he appreciated the work of everyone involved, recognizing the hard work required to maintain accreditation.

<u>Initial Accreditation – NCIS – Basic Physical Security Training Program</u> – Board Member Paul Baker reported the results of the Naval Criminal Investigative Service Basic Physical Security Training Program (BPSTP) review. He reviewed the training program and announced the Board approved the BPSTP for its initial accreditation.

Assistant Director Andy Hogan, NCISHQ Human Resources, accepted the accreditation certificate on behalf of Director Mark Clookie, thanking the Board. He also thanked staff members Scott Hickson and Paul Kasper for their hard work, "This program is the cornerstone for team members as they work to protect assets worldwide. Our accreditation is critical to supporting our training efforts as we support the needs of the field".

<u>Initial Accreditation – USMS – Detention Enforcement Officer/Aviation</u>
<u>Enforcement Officer Program</u> – Board Member Owen Harris reported the results of the U.S. Marshals Service Detention Enforcement Officer/Aviation Enforcement Officer Program (DEO/AEO) review. He recognized the U.S. Marshals Service as the oldest federal law enforcement agency. He praised the presentation in the Board Review Committee yesterday and commended USMS Accreditation Manager Don Hines for the presentation. Mr. Harris then announced the Board approved the DEO/AEO Program for its initial accreditation.

On behalf of Director Hylton, Mr. William T. Fallon, Assistant Director for Training, thanked the Board and the assessment team. Mr. Fallon reported that the Director announced the USMS 2011 Distinguished Service Awards, one of which went to Don

Hines, Cynthia Wild, and Darrell D. Williams of the USMS Training Division in Glynco, Georgia, for the accreditation of the Basic Deputy U.S. Marshal program.

Mr. Fallon also noted that some of the questions brought up in the Board Review Committee yesterday stirred some thoughts for their advanced programs they hope to have accredited in the future.

<u>Reaccreditation – FAMS – FAMTP-I</u> – Board Member Kristine Blackwell reported the results of the Federal Air Marshal Service Federal Air Marshal Training Program I (FAMTP-I) review. Col. Blackwell gave a brief overview of the program and announced the Board approved the FAMTP-I for reaccreditation.

Michael Novak, TSA Assistant Administrator, Training and Workforce Engagement, thanked the Board and thanked the Federal Law Enforcement Training Center, noting they are a great partner with TSA on this program. Mr. Novak also thanked Jason Worchel, Branch Manager, Training Development and Support Branch, and Joseph D'Angelillio, Deputy Division Director, Law Enforcement and Industry Training Division, for their hard work; and Tom Kost, Division Director, Law Enforcement and Industry Training Division, recognizing his commitment to the process with the other programs he will put forward in the future.

<u>Reaccreditation – FLETC - LEITP</u>— Board Member Terry Stuart reported the results of the Federal Law Enforcement Training Center's (FLETC) Law Enforcement Instructor Training Program (LEITP) review. Mr. Stuart reviewed the program, noting most of the Partner Organizations at the FLETC rely on this program for their instructor needs. He then announced the Board approved the LEITP for reaccreditation.

FLETC Director Connie Patrick accepted the certificate of reaccreditation, thanking the FLETA Board and Don Smith, FLETC Accreditation Manager. She noted "Nothing is of more importance than core law enforcement instructor training – it is the foundation of our future." She congratulated the Board for ten years of "hard work", saying "nothing has done more to professionalize law enforcement training". Director Patrick also said she was happy to hear the Board will be working on establishing standards for Elearning.

<u>Reaccreditation – FLETC - LEDITP</u> – Board Member Charlie DeVita reported the results of the Federal Law Enforcement Training Center's (FLETC) Law Enforcement Driver Instructor Training Program (LEDITP) review. Mr. DeVita reviewed the program and thanked the assessment team. He also congratulated Bruce P. Brown and his team for their fine work. He then announced the Board approved the LEITP for reaccreditation.

Dominick Braccio, FLETC Assistant Director for Training, accepted the certificate for reaccreditation, thanking the Board. Mr. Braccio noted that in 13 of the last 14 years, vehicle accidents were the leading cause of law enforcement deaths nationally. He said "we are working to help our brother and sisters in state and local to reduce that."

Reaccreditation – FLETC - MLETP – Board Member Sheldon Greenberg reported the results of the Federal Law Enforcement Training Center's (FLETC) Marine Law Enforcement Training Program (MLETP) review. Dr. Greenberg reviewed the program and announced the Board approved the MLETP for reaccreditation.

Assistant Director Dominick Braccio accepted the certificate for reaccreditation, thanking the assessment team. Mr. Braccio mentioned the research conducted by FLETA Office of Accreditation Program Manager Billy McLeod where he analyzed several years of evaluations to identify return on expectations. Mr. Braccio explained that identifying return on expectations is critical for both the FLETC and the partner organizations they support.

III. Congratulatory Letters

FLETA Board Chairperson Don Webb read a letter from President Barack Obama to the Board meeting attendees, recognizing the 10th anniversary. He also read a document that was read into the Congressional Record from the Hon. Jack Kingston of Georgia, congratulating FLETA on their 10th anniversary.

IV. Approval of Minutes from Previous Board Meeting

FLETA Board Chairperson Don Webb called for approval of the minutes of the FLETA meeting held March 22, 2012, in Hilton Head, South Carolina. A motion to approve the minutes was made by Angela Hrdlicka, seconded by Nick Trotta, and carried unanimously.

V. Committee Reports

A. Strategic Planning Committee – Board Chairperson Don Webb reported on the Strategic Planning Committee's activities. The committee met yesterday and finalized the new Strategic Plan for 2012-2016. It includes four strategic goals: FLETA Quality, Clearinghouse, FLETA Recognition (Outreach), and FLETA in the Electronic Environment. The revised Strategic Plan was approved by the Board in Executive Session.

Paul Baker moved to accept the Strategic Planning Committee report. Sheldon Greenberg seconded the motion. The motion was carried unanimously.

B. Recruitment Committee – Angela Hrdlicka reported that the committee met yesterday and made several recommendations to the Board on filling three vacant seats. The Office of Accreditation will invite two agencies and one individual to sit on the Board.

Sheldon Greenberg moved to accept the report of the Recruitment Committee. Pat Corcoran seconded the motion, which was carried unanimously.

C. Recognition & Anniversary Committee – Don Webb reported that the committee met yesterday and voted to announce the FLETA Agency award and FLETA Team

Leader award at the November Board meeting in Baltimore. The FLETA 10th anniversary will be formally celebrated at the November Board meeting. A request has been submitted for the USMC Band and Honor Guard, and the anniversary video will be shown.

Tim Danahey moved to accept the report of the Recognition and Anniversary Committee. Mike Novak seconded the motion, which was carried unanimously.

VI. General Reports

A. Office of Accreditation Updates – Gary Mitchell reviewed the current number of accredited academies and programs, and the number of applications in progress. He then mentioned the next Board meeting will be in Baltimore, Maryland, October 30 – November 1, 2012. More information will be published on the website as the Board meeting dates approach. The full report of the FLETA Office of Accreditation activities is attached.

Assessors (Tab 6)

Thirty-six assessors (seven more than last cycle), twenty-two shadow assessors (eight more than last cycle), and 38 self-assessors (12 more than last cycle) were used, for a total cost of \$53,888.38 (\$12,146.39 more than last cycle). Assessors were from 28 (+3) different agencies, averaged 3.56 (+0.63) FLETA assessments per assessor, and participated in an average of 3.84 (+1.39) self-assessments per assessor.
