Angela Hrdlicka is a Special Agent (SA) with the Department of Interior Office of Inspector General, and has been detailed to the Inspector General Criminal Investigator Academy (IGCIA) as the Executive Director since August 2006. She is responsible for the development, implementation and administration of law enforcement training for more than seventy federal Offices of Inspectors General, in addition to various state/local and military Inspector General personnel.

SA Hrdlicka began her law enforcement career in 1990 as a criminal investigator with the U.S. Secret Service (USSS) in the Washington Field Office. She conducted a variety of criminal investigations, including major economic crimes such as bank and access device fraud, counterfeit currency investigations, forgery of U.S. Treasury obligations, food stamp fraud and identity theft. She performed numerous and diverse protective advance assignments in the U.S. and abroad, often utilizing her Russian language skills in doing so. While assigned to the Protective Intelligence squad, she managed investigations of individuals and groups that posed potential threats to those under the protection of the USSS, and acquired expertise in conducting interviews of mentally ill subjects and evaluating their dangerousness. In 1997, SA Hrdlicka was assigned to the Intelligence Division in USSS headquarters, where she led many foreign and domestic protective intelligence advance assignments for the President, Vice-President and First Lady of the United States, and provided oversight of protective intelligence investigations nationwide. SA Hrdlicka was subsequently assigned to the James J. Rowley Training Center (RTC), where she used her subject matter expertise in protective intelligence to instruct, develop and revise that curriculum for the agency's Special Agent Training Course (SATC). In 2001, she was transferred to the RTC office at the Federal Law Enforcement Training Center (FLETC), Glynco, Georgia, as the program manager of the SATC counterfeit curriculum. SA Hrdlicka developed, implemented and provided instruction in an innovative 7-day block of training that was delivered to newly hired USSS agents for several years. She also served as a continuing case coordinator, mentoring newly hired criminal investigators during the FLETC's Criminal Investigator Training Program. In 2003, she was promoted to Assistant Special Agent in Charge, as the agency's representative to FLETC, and was responsible for managing all USSS training, staff and students at FLETC.

Since 2003, SA Hrdlicka has been an active participant in the activities of the Federal Law Enforcement Training Accreditation (FLETA) Board as an Assessor and member of the Strategic Planning and the Standards Steering committees. She currently serves on the FLETA Board, as well as the Board of Directors for the Association of Inspectors General. She received her Bachelor of Arts degree in political science and comparative area studies (Russia and Latin America) from Duke University in 1988. She lives in Brunswick, Georgia, with her husband and two sons.
