Program Description	Faculty members from disadvantaged backgrounds with a professional health care degree/certificate may receive loan repayment assistance in exchange for teaching at educational institutions that provide training for health care professionals.

Financial Benefits	<ul style="list-style-type: none"> ✓ Loan repayment assistance up to \$40,000 ✓ Funding to offset the tax burden ✓ Must receive matching funds from employers unless the institution receives a waiver from HRSA 		
Tax Liability	Taxable; participants receive a tax liability benefit equal to 39% of the loan repayment amount.

Application Requirements	<ul style="list-style-type: none"> ▪ U.S. citizen (U.S. born or naturalized), U.S. national, or Lawful Permanent Resident ▪ School-produced certification to demonstrate having grown up with a disadvantaged background based on environmental and/or economic factors ▪ Full-time or part-time faculty position for a minimum of 2 years (at an eligible health professions school)
