ORDER INSTITUTING ADMINISTRATIVE PROCEEDINGS PURSUANT TO SECTION 203(f) OF THE INVESTMENT ADVISERS ACT OF 1940, MAKING FINDINGS, AND IMPOSING REMEDIAL SANCTIONS

I.

The Securities and Exchange Commission ("Commission") deems it appropriate and in the public interest that public administrative proceedings be, and hereby are, instituted pursuant to Section 203(f) of the Investment Advisers Act of 1940 ("Advisers Act") against Drew Clayton Peterson ("Drew Peterson" or "Respondent").

II.

In anticipation of the institution of these proceedings, Respondent has submitted an Offer of Settlement (the "Offer") which the Commission has determined to accept. Solely for the purpose of these proceedings and any other proceedings brought by or on behalf of the Commission, or to which the Commission is a party Respondent consents to the Commission's jurisdiction over him and the subject matter of these proceedings and to the entry of this Order Instituting Administrative Proceedings Pursuant to Section 203(f) of the Investment Advisers Act of 1940, Making Findings, and Imposing Remedial Sanctions ("Order"), as set forth below.

## III.

On the basis of this Order and Respondent's Offer, the Commission finds that:

- 1. Drew Peterson, age 35, resides in Denver, Colorado. From 2004 to August 2010, Peterson worked as a financial adviser at Private Capital Management, Inc., a registered investment adviser based in Denver, Colorado. While working at Private Capital Management, he held a Series 65 license.
- 2. On August 5, 2011, the Commission filed a civil action against Drew Peterson in <u>SEC v. H. Clayton Peterson et al.</u>, Civil Action No. 11-CV-5448 (S.D.N.Y.). On June 1, 2012, the Court entered an order permanently enjoining Drew Peterson, by consent, from future violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.
- 3. The Commission's complaint alleged that, in connection with the purchase or sale of securities, Drew Peterson knew, recklessly disregarded, or should have known, that material non-public information he received from his father H. Clayton Peterson was disclosed or misappropriated in breach of a fiduciary duty, or similar relationship of trust and confidence, and Drew Peterson is liable for his own trading as well as trades executed by his clients, relatives, and friends because Drew Peterson directly or indirectly caused these persons to place trades and/or unlawfully tipped inside information to them.
- 4. On August 5, 2011, Drew Peterson pled guilty to one count of securities fraud and one count of conspiracy to commit securities fraud in violation of 15 U.S.C. §§ 78j(b) and 78ff and 18 U.S.C. § 371 before the United States District Court for the Southern District of New York in <u>United States v. Drew Clayton Peterson</u>, 11-CR-00664 (RPP).
- 5. The counts of the criminal information to which Drew Peterson pled guilty alleged, <u>inter alia</u>, that Drew Peterson, and others, participated in a scheme to defraud by executing securities trades based on material nonpublic information that had been disclosed or misappropriated in violation of duties of trust and confidence, and that he unlawfully, willfully and knowingly did so, directly and indirectly, by use of the means and instrumentalities of interstate commerce, and of the mails, and of the facilities of national securities exchanges, in connection with the purchase and sale of securities.

## IV.

In view of the foregoing, the Commission deems it appropriate and in the public interest to impose the sanctions agreed to in Respondent Drew Peterson's Offer.

Accordingly, it is hereby ORDERED pursuant to Section 203(f) of the Advisers Act that Respondent Drew Peterson be, and hereby is:

barred from association with any broker, dealer, investment adviser, municipal securities dealer, municipal advisor, transfer agent, or nationally recognized statistical rating organization.

Any reapplication for association by the Respondent will be subject to the applicable laws and regulations governing the reentry process, and reentry may be conditioned upon a number of factors, including, but not limited to, the satisfaction of any or all of the following: (a) any disgorgement ordered against the Respondent, whether or not the Commission has fully or partially waived payment of such disgorgement; (b) any arbitration award related to the conduct that served as the basis for the Commission order; (c) any self-regulatory organization arbitration award to a customer, whether or not related to the conduct that served as the basis for the Commission order; and (d) any restitution order by a self-regulatory organization, whether or not related to the conduct that served as the basis for the Commission order.
