Under the terms of the 2012 Appropriation, a 0.189 percent across-the-board rescission is applied to discretionary budget authority available in FY 2012. As a result, all current year discretionary funds have been reduced as well as total advance appropriations from FY 2011 available in FY 2012. Advances from FY 2011 are reduced by \$41,403 thousand and total \$21,864,598 thousand after the reduction. Advance appropriations from FY 2012 available in FY 2013 are not affected by the 0.189 percent across-the-board rescission, and total \$22,597,001 thousand.
