# Table 1 ENFORCEMENT MILESTONES FISCAL 2011

- Obtained orders in SEC judicial and administrative proceedings requiring securities violators to disgorge illegal profits of approximately \$1.878 billion and to pay penalties of approximately \$928 million.
- Sought orders barring 82 defendants and respondents from serving as officers or directors of public companies.
- Sought emergency relief from federal courts in the form of temporary restraining orders (TROs) to halt ongoing fraudulent conduct in 39 actions, and sought asset freezes in 42 actions.
- Filed 9 actions to enforce investigative subpoenas.
- Halted trading in securities of 276 issuers about which there was inadequate public disclosure.

In SEC-related criminal cases, prosecutors filed 137 indictments, informations, or contempts in Fiscal 2011.

#### **Right to Financial Privacy**

Section 21(h) of the Securities Exchange Act of 1934 [15 U.S.C. 78u(h)(6)] requires that the Commission "compile an annual tabulation of the occasions on which the Commission used each separate subparagraph or clause of [Section 21(h)(2)] or the provisions of the Right to Financial Privacy Act of 1978 [12 U.S.C. 3401-22 (the RFPA)] to obtain access to financial records of a customer and include it in its annual report to the Congress." During the fiscal year, the Commission issued 2 subpoenas under Section 21(h)(2)(A)(4). Set forth below are the number of occasions on which the Commission obtained customer records pursuant to the provisions of the RFPA:

Prefers to matters at the investigative stage, and excludes those that are open solely due to litigation, collections, distributions, and other post-litigation activity. Also excludes investigations in the closing process. Previous years' reports included aggregate count of open investigations at all stages. Advances in the Division's case management systems now allow for more refined reporting of investigations at various stages. Since the count now refers only to ongoing investigations, the count is significantly less than the prior year's count of investigations at all stages, and is not an indication of a decrease in investigative activity.

#### **INVESTOR COMPLAINTS AND QUESTIONS**

During FY 2011, the SEC's Office of Investor Education and Advocacy closed 33,632 files relating to complaints, questions, and other contacts received from investors. Comparable data for prior fiscal years is not available due to a change in reporting methodology.
