SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 18) granting-in-part complainant's motion for summary determination. The ID grants the motion only in regard to the importation requirement and the economic prong of the domestic industry requirement.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on May 30, 2008, based on a complaint filed by John Mezzalingua Associates, Inc. d/b/a PPC, Inc. ("PPC") of East Syracuse, New York. 73 *Fed. Reg.* 31145 (May 30, 2008). The complaint alleges violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain coaxial cable connectors and components thereof and products containing the same by reason of infringement of United States Patent Nos. 6,558,194; 5,470,257 ("the '257 patent"); D440,539; and D519,076. The complaint names eight respondents. Subsequent to institution two respondents were terminated from the investigation based on consent orders, and four other respondents were found in default.

On March 2, 2009, PPC filed a motion for summary determination that the remaining respondents and those in default have violated section 337 by reason of infringement of certain claims of the '257 patent. On March 12, 2009, the remaining Respondents, Fu Ching Technical Industry Co. Ltd. and Gem Electronics, Inc., opposed PPC's motion. On March 12, 2009, the Commission Investigative Attorney supported PPC's motion only as to the importation requirement and the economic prong of the domestic industry requirement.

On April 6, 2009, the ALJ issued the subject ID granting-in-part PPC's motion for summary determination. The ID grants the motion only in regard to the importation requirement with respect to the accused products and the economic prong of the domestic industry requirement for the '257 patent. No petitions for review were filed.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
