**SUMMARY**: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 16) terminating the investigation as to Synology Inc. and Synology America Corp. (collectively, "Synology") on the basis of a consent order in the above-captioned investigation. The Commission has issued the subject consent order.

**SUPPLEMENTARY INFORMATION**: The Commission instituted this investigation on September 2, 2009, based on a complaint filed by Samsung Electronics Co. ("Samsung") of Korea. The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain flash memory and products containing same by reason of infringement of certain claims of U.S. Patent Nos. 6,930,050 and 5,740,065. The Commission's notice of investigation named numerous respondents, including Synology.

On June 30, 2010, the ALJ issued the subject ID, granting a joint motion to terminate the investigation with respect to Synology on the basis of a consent order. No petitions for review were filed.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
