SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 72) extending the target date by six weeks to December 12, 2011.

**SUPPLEMENTARY INFORMATION**: The Commission instituted this investigation on February 24, 2010, based on a complaint filed by Apple Inc., f/k/a Apple Computer, Inc. of Cupertino, California ("Apple"). 75 Fed. Reg. 8399-400. The complaint, as amended and supplemented, alleges violations of Section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain mobile communications and computer devices and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 5,379,431; 5,455,599; 5,519,867; 5,915,131; 5,920,726; 5,969,705; 6,343,263; 6,424,354; and RE39,486. The complaint further alleges the existence of a domestic industry. The Commission's notice of

investigation named Nokia Corporation of Espoo, Finland and Nokia Inc. of White Plains, New York as respondents.

On June 3, 2011, the ALJ issued the subject ID, extending the target date by six weeks to December 12, 2011, pursuant to Commission Rule 210.51(a) (19 C.F.R. § 210.51(a)). No petitions for review were filed.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
