**SUPPLEMENTARY INFORMATION:** This investigation was instituted on April 2, 2010, based upon a complaint filed on behalf of Geoffrey Lee McCabe of Hollywood, Florida ("McCabe") on February 26, 2010, and supplemented on March 18, 2010. 75 *Fed. Reg.* 16838 (April 2, 2010). The complaint alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain stringed musical instruments and components thereof by reason of infringement of certain claims of United States Patent Nos. 5,986,191; 6,175,066; 7,470,841; the '831 patent; and the '094 patent. The notice of investigation named as respondents Floyd Rose Guitars of Redmond, WA; Floyd Rose Marketing, Inc. of Neptune, NJ; Davitt & Hanser Music Co. d/b/a HHI of Hebron, KY; Ping

Well Indus. Co., Ltd. of Taichung, Taiwan; Ibanez, Inc. (Hoshino) US of Bensalem, PA; Ibanez, Inc. (Hoshino) Japan; and Fuji Gakki Co., Ltd., of Nagoya, Japan.

On May 4, 2010, complainant McCabe filed an unopposed motion pursuant to 19 C.F.R. § 210.21(a) for termination in part as to all claims of the '831 patent and the '094 patent. On May 27, 2010, the ALJ issued the subject ID, granting McCabe's motion for termination. No petitions for review were filed.

The Commission has determined not to review the subject ID.

This action is taken under the authority of section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and of section 210.42(h) of the Commission's Rules of Practice and Procedure (19 CFR § 210.42(h)).
