SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 25) extending the target date in the above caption investigation by five and a half weeks to August 23, 2012.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on November 8, 2010, based on a complaint filed by Motorola Mobility, Inc. of Libertyville, Illinois ("Motorola"). 75 *Fed. Reg.* 68619-20 (Nov. 8, 2010). The complaint alleges violations of Section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain wireless communication devices, portable music and data processing devices, computers and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 6,272,333; 6,246,862; 6,246,697; 5,359,317 ("the '317 patent"); 5,636,223; and 7,751,826. The complaint further alleges the existence of a domestic industry. The Commission's notice of investigation named Apple Inc. of Cupertino, California as respondent. The Commission later partially terminated the investigation as to claim 1 of the '317 patent. Notice (June 28, 2011).

On November 1, 2011, the ALJ issued the subject ID pursuant to Commission Rule 210.51(a) (19 C.F.R. § 210.51(a)), extending the target date by five and a half weeks to August 23, 2012, due to the fact that he was recently assigned to this investigation and because the evidentiary hearing, which was originally scheduled for August 22-26, 2011, has not yet occurred. The final ID will be due to issue on April 23, 2012. No petitions for review were filed.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
