NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION GRANTING A JOINT MOTION TO TERMINATE THE INVESTIGATION AS TO RESPONDENT A.G. FINDINGS AND MFG. CO., INC., D/B/A BALLISTIC ON THE BASIS OF A SETTLEMENT AGREEMENT

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 16) granting a joint motion to terminate Respondent A.G. Findings and Mfg. Co., Inc. d/b/a Ballistic of Sunrise, Florida ("A.G. Findings") from the investigation on the basis of a settlement agreement.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on June 30, 2011, based on a complaint filed by Otter Products, LLC of Fort Collins, Colorado ("Otter"). 76 Fed. Reg. 38417 (June 30, 2011). The complaint alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain protective cases and components thereof by reason of infringement of various claims of United States Patent Nos. 7,933,122; D600,908; D617,784; D615,536; D617,785; D634,741; and D636,386; and United

States Trademark Registration Nos. 3,788,534; 3,788,535; 3,623,789; and 3,795,187. The complaint named several respondents, including A.G. Findings.

On October 18, 2011, Otter and A.G. Findings filed a joint motion to terminate the investigation as to A.G. Findings based upon the execution of a settlement agreement. On October 31, 2011, the Commission investigative attorney filed a response in support of the motion. No other responses to the motion were filed.

On November 2, 2011, the ALJ issued the subject ID, granting the joint motion to terminate A.G. Findings from the investigation. The ALJ found that the parties complied with Commission Rule 210.21(b) (19 C.F.R. § 210.21(b)). The ALJ also found that terminating A.G. Findings from the investigation would not be contrary to the public interest. None of the parties petitioned for review of the ID.

The Commission has determined not to review the ID. Accordingly, this investigation is terminated with respect to A.G. Findings.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
