SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 13) of the presiding administrative law judge ("ALJ") granting a motion by Complainant to terminate the investigation as to Respondent E&S International Enterprises, Inc. on the basis of settlement.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on July 19, 2011, based on a complaint filed by Vizio, Inc. of Irvine, California ("Vizio"). 76 Fed. Reg. 42728 (July 19, 2011). The complaint alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital televisions and components thereof by reason of infringement of various claims of United States Patent Nos. 5,511,096; 5,621,761; 5,703,887; 5,745,522; and 5,511,082. The complaint named several respondents, including E&S International Enterprises, Inc. of Van Nuys, California ("E&S").

On August 24, 2011, Vizio filed a motion to terminate the investigation as to E&S on the basis of settlement. On August 31, 2011, the Commission investigative attorney filed a response in support of the motion.

On August 31, 2011, the ALJ issued the subject ID (Order No. 13) terminating Respondent E&S from the investigation. None of the parties petitioned for review of the ID. The Commission has determined not to review the ID. Accordingly, Respondent E&S is terminated from the investigation.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
