## NOTICE OF COMMISSION DECISION NOT TO REVIEW TWO INITIAL DETERMINATIONS TERMINATING THE INVESTIGATION AS TO FOUR RESPONDENTS ON THE BASIS OF CONSENT ORDERS; ISSUANCE OF CONSENT ORDERS; AND DETERMINING NOT TO REVIEW A THIRD INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO FOUR ADDITIONAL RESPONDENTS ON THE BASIS OF A SETTLEMENT AGREEMENT

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determinations ("IDs") (Order Nos. 10-12) terminating the above-captioned investigation as to certain respondents on the basis of consent orders, and as to other respondents on the basis of a settlement agreement.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on January 11, 2012, based on a complaint filed by Walker Digital LLC of Stamford, Connecticut ("Walker"), alleging a violation of section 337 in the importation, sale for importation, and sale within the United States after importation of certain Blu-ray disc players, components thereof, and products containing the same, by reason of the infringement of certain claims of U.S. Patent No. 6,263,505. 77 *Fed. Reg.* 1725 (Jan. 11, 2012). The notice of institution named thirty-five respondents.

On February 8, 2012, Walker and respondents Haier Group Corporation of Qindao, China; and Haier America Trading, LLC of New York, New York (collectively, "Haier") moved to terminate the investigation as to Haier by reason of a consent order. On April 2, 2012, the ALJ granted the motion as an ID. Order No. 10.

On February 13, 2012, Walker and respondents Inkel Corporation of Incheon, Korea; and Sherwood America, Inc. of La Mirada, California (collectively, "Inkel") moved to terminate the investigation as to Inkel by reason of a consent order. On April 2, 2012, the ALJ granted the motion as an ID. Order No. 11.

On February 10, 2012, Walker and respondents D&M Holdings, Inc. of Kanagawa, Japan; D&M Holdings U.S. Inc. of Mahwah, New Jersey; Denon Electronics (USA), LLC of Mahway, New Jersey; and Marantz America LLC of Mahwah, New Jersey (collectively, "D&M") moved to terminate the investigation as to D&M by reason of a settlement agreement. On April 4, 2012, the ALJ granted the motion as an ID. Order No. 12.

No petitions for review of the IDs were filed. The Commission has determined not to review the IDs. The Commission has issued the subject consent orders.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in sections 210.21 and 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. §§ 210.21, 210.42).
