Return information is limited to items such as tax isability and estimated tax payments. Account transcripts are available for most returns. Most requests will be processed within 30 calendar days.					o items such as tax liability
۰	Record of Account, which is a combination of line item information and later adjustments to the account. Available for current year and 3 prior tax years. Most requests will be processed within 30 calendar days.					
7	Verification of Nonfiling, which is proof from the IRS that you did not file a return for the year. Current year requests are only available after June 15th. There are no availability restrictions on prior year requests. Most requests will be processed within 10 business days.					
8	Form W-2, Form 1099 series, Form 1098 series, or Form 5498 series transcript. The IRS can provide a transcript that includes data from these information returns. State or local information is not included with the Form W-2 information. The IRS may be able to provide this transcript information for up to 10 years. Information for the current year is generally not available until the year after it is filed with the IRS. For example, W-2 information for 2007, filed in 2008, will not be available from the IRS until 2009. If you need W-2 information for retirement purposes, you should contact the Social Security Administration at 1-800-772-121. Most requests will be processed within 45 days.

- 1. If you filed a joint tax return, make sure you include both names on the Form  $4506\text{-}\mathrm{T}$ .
- 2. The third party is your mortgage servicer. - 3. If you did not file a tax return for the year, make sure to check box #7.
- 4. Even if you file a joint tax return, you only need one signature (the person listed on line 1a) to file the Form 4506-T. NOTE: The IRS must receive your form within 60 days of the signature date.
