FOR THE QUARTERLY UPDATE, SUEY NUMBERS, THE THEY ARE THROUGH FISCAL YEAR 08 WHICH ENDED SEPTEMBER 30th, 2008.

AS YOU CAN SEE WE ENDED FISCAL YEAR 07 WITH 180,659 SUBMISSIONS. WE CLOSED OUT FISCAL YEAR 08 WITH 202,000, 366 FOR A 12% GROWTH IN APPLICATIONS.

AOR, THE AUTHORIZE ORG NIGHATION OF REPRESENTATIVES THOSE WHO HAVE THE AUTHORITY WITHIN THE ORGANIZATION TO SUBMIT GRANTS AS GROWN 42% OVER FISCAL YEAR 07, FOR A TOTAL OF 130,027.

OUR CONTACT CENTER CONTINUED TO GROW AS WELL.

ONE%; 213,566 CONTACTS REPRESENTEDENTIOUS MAILS REPRESENT E-MAILS AS WELL AS CALLS.

I WOULD ALSO LIKE TO POINT OUT, AORs, AUTHORIZE ORGANIZATIONAL REPRESENTATIVES, 1 OF THE COMMON CALLS FROM TIME TO TIME INTO THE HELP DESK OR CONTACT CENTER IS FOR AORs WITH ISSUES SUBMITTING. ONE OF THOSE ISSUES ARE, YOU MAY HAVE BEEN REGISTERED OR YOU ARE REGISTERED MULTIPLE TIMES AS AORS WITH DIFFERENT ORINIZATIONS.-ORGANIZATIONS.

WHEN SUBMITTING A GRANT APPLICATION, YOU MUST USE YOUR CURRENT ACTIVE AOR TO PROCESS YOUR APPLICATION ACCORDINGLY.

ALL THESE PARTS, ALL THESE PIECESOT WEB SITE ARE TO PROVIDE YOU WITH INFORMATION TO ASSIST YOU.

ALSO TO RECAP FISCAL YEAR 07--I'M SORRY 08 FROM THE OUTREACH PER SPECTIVE BEICIDES OUR QUARTERLY WEBCAST, WE CONDUCTED 54 DIFFERENT PRESENTATIONS, TRAINING SESSIONS, TO THE APPLICANT COMMUNITY SUCH SEGS ARE FOR NONPROFITS, ORG NIGHATIONS,-HAD ORGANIZATIONS, INSTITUTIONS AND CONGRESSIONAL OFFICES, THOSE 54 DIFFERENT PRESENTATIONS TOTALED OVER 8200 PEOPLE IN ATTENDANCE, SPECIFICALLY WE PRESENTED 13 TIMES TO CONGRESS FOR A TOTAL OF 1440 PEOPLE. SO AS CAN YOU SEE, WE'RE OUT THERE PROMOTING THE GRANTS .GOV AS WELL AS THE AGENCY.

NOW WHAT HAPPENS WITH THE GRANTS .GOV BLOG IS REPRESENTATIVES FROM THE PROGRAM MANAGEMENT OFFICE ALL 8 OF US, WE HAVE THE ABILITY AND WE GO IN AND POST INFORMATION IN THERE THAT'S KEY TO YOU, KEEPING YOU UP TO DATE WITH THE PROGRAM.

SOME OF THE INFORMATION WE ALSO POST ON THE REGULAR WEB SITE BUT ANOTHER KEY ASPECT OF THE GRANTS .GOV BLOG IS YOU CAN SEE NEW OPPORTUNITIES POSTED.

YOU CAN ALSO SEE SYSTEM STATUS ON THE TOP LEFT-HAND SIDE OF THE SCREEN, ALL RIGHT?

MOSTLY ALL THE TIME THE SYSTEM IS GREEN.

IF THERE ARE SLOW SUBMISSION TIMES WE'LL CHANGE THAT TO YELLOW AND IF, THE SYSTEM DEFINED AND APPLY FUNCTIONALITY IS DOWN, TELL BE RED.

ALSO IMPORTANT TO NOTE, BESIDES THE BLOG,OT GRANTS .GOV SITE ITSELF, IF THERE ARE SYSTEM ISSUES WE POST THEM ABOVE THE LEFT-HAND SIDE NAVIGATION BAR.

AS AN FYI, YOU ALWAYS WANT TO LOOK TO WHAT'S NEW THIS WEEK AT GRANTS.GOV FOR KEY UPDATES AND INFORMATION.

FOR EXAMPLE IN SEPTEMBER 30th, TO OCTOBER FIRST, ALL THE FEDERAL AGENCIES HAD A LARGE NUMBER OF CLOSES, WHAT WE DID WAS 4 WEEKS PRIOR WE POSTED AN ALERT ON THE--UNDER WHAT'S NEW IN WEEK, GIVEN THE APPLICANT COMMUNITY AND UPDATE THAT WE RECOMMEND SUBMITTING EARLY

ANOTHER UPDATE WE'VE DEAN IS AN RSS FEED.

REAL SIMPLE SYNDICATION, MANY OF YOU ARE FAMILIAR WITH RSS FEED. THERE'S A NUMBER OF SMALL PROGRAMS OUT THERE THAT YOU UTILIZE TO RECEIVE THE RSS FEED.

THE RSSFEED ITSELF FOR GRANTS.GOV DISPLAYS THE NEW GRANT OPPORTUNITIES POSTED.

WHAT HAPPENS IS, DAILY GRANTS.GOV, WE SEND OUT 700,000 E-MAIL NOTIFICATIONS OF NEW GRANT POSTINGS WE ARE UNDERGOING AN INITIATIVE TO TERMINATE THAT SERVICE JANUARY 31st OF 2009.

SO WHAT WE WILL DO OVER THE NEXT SEVERAL MONTH SYSTEM COMMUNICATE THAT LIKE WE'RE DOING NOW, WE HAVE OUR NEXT WEB CAST IN JANUARY WE INCLUDED THAT INFORMATION IN OUR NEWS LET THEY'RE WENT OUT YESTERDAY SO THE BECOME LINE IF YOU ARE RECEIVING THE DAILY NOTEISK OF NEW GRANT POSTINGS, NEW OPPORTUNITY, THAT WILL BE TERMINATED JANUARY 31st 2009 AND YOU NEED TO UTILIZE THE RSSPAYS FEED FOR THAT INFORMATION.

NOW 1 OF THE THINGS ALSO IS WE'LL TALK ABOUT OUR BUILD 2008-003 BUT IN OUR BUILD 200-02, WHAT WE IMPLEMENTED FOR THE AGENCY AND OF COURSE THE APPLICANT WAS THE FUNCTIONALITY FOR E-MAIL NOTIFICATION IF THERE WAS A CHANGE TO AN OPPORTUNITY.

SO WHAT HAPPENS IS WHEN AN OPPORTUNITY IS POSTED YOU THE APPLICANT CAN SIGN UP TO RECEIVE E-MAIL NOTIFICATIONS OF CHANGES TO THAT OPPORTUNITY, THAT FUNCTIONALITY WILL REMAINING ON IN PLACE AFTER JANUARY 31st.

WHAT HAPPENS IS WHEN THE AGENCIES THEMSELVES, IF THEY MODIFY THE OPPORTUNITY, THERE IS A TEXT BOX IN THERE FOR THEM TO TYPE IN A DESCRIPTIVE NARRATIVE OF WHAT'S BEEN CHANGED.

ONCE THEY DO THAT, YOU WILL RECEIVE AN E-MAIL NOTIFICATION SO THAT WILL STILL TAKE PLACE FEBRUARY 1.

ONE OTHER THING WE'VE DONE, I MENTIONED THE APPLICANT RESOURCES PAGE, WE HAVE UNDER THERE A NEW APPLICANT TROUBLE SHOOTING PAGE.

WHAT WE'VE DONE, OUR CONTACT CENTER AT THIS POINT IN TIME HAS 484 SOLUTIONS BUILT INTO THE KNOWLEDGE BASE TO ASSIST AND ANSWER QUESTIONS.

WHAT HAPPEN SYSTEM A LOT OF THE CALLS ARE THE SAME. THE NUMBER 1 CALLS ARE STILL PEOPLE LOOKING FOR FINANCIAL ASSISTANCE.

BUT 1 OF THE THINGS WE'VE DONE IS WE'VE TAKEN THE MOST COMMON QUESTION AROUND SYSTEM ISSUES OR JUST IN GENERAL AND WE'VE CREATED AN APPLICANT TROUBLE SHOOTING PAGE SO IF YOU HAVE QUESTIONS ABOUT HOW YOU WANT TO CHECK YOUR AOR STATUS, IF YOU HAVE TECHNICAL QUESTIONS, YOU ARE HAVING ISSUES SUBMITTING, YOU KNOW THERE ARE TROUBLE SHOOTING THINGS IN THEIR SUCH AS CLEARING YOUR COOKIE, CLEARING YOUR CACHET AND IT'S IN DETAILED THERE.

SO WE HOPE YOU FIND THAT BENEFICIAL AND IF YOU HAVE ANY SUGGESTIONS OR QUESTIONS TO THAT WE ARE ALWAYS LOOKING TO ADD TO IT.

WE WORK WITH THE CONTACT CENTER ITSELF, I OVERSEE THE CONTACT CENTER, SO AS PART OF THE WEB SITE, WE MAKE SURE THERE ARE LINKS THERE.

THIS IS MAINLY TOWARD THE GRANTERS OUT THERE, THEY WOULD FIND THE INFORMATION USEFUL TOO SA WE TRANSITION COMPLETELY TO THE ADOBE FUNCTIONALITY.

AS OF NOVEMBER 30th, YOU CAN ONLY BE THE LAST DAY NAY YOU CAN POST--THAT CAN YOU POST IN PURE EDGE, AFTER THAT DATE IT'S STRICTLY ADOBE SO THAT'S THE CUT OFF DATE FOR THE AGENCIES, AS OF NOVEMBER 30th IT'S THE DAY THEY HAVE TO REMEMBER, THE LAST DAY THEY COMPOSE IN PURE EDGE.

IF THEY NEED TO MODIFY MICHAEL, BETWEEN NOW AND THE ACTUAL CUT OFF DATE WHICH IS ALSO JANUARY 31, 2 THIS HAPPENED AND 9, THEY NEED TO CONTACT THE PMO, EITHER MARY TOP MAN AND MYSELF, AND WE CAN MAKE MODISHS THEY NEED FOR THE POSTINGS THEY HAVE UP.

SO IT WON'T BE THAT KAY CAN'T MODIFY OPPORTUNITIES AND PURE EDGE FOR THAT 2 MONTH SPAN.

THERE IS A MECHANISM BUT WE WILL CONTROL IT.

AND AGAIN, MY SECOND POINT AGAIN WHICH I'VE ALREADY MENINGED IS THE LAST DAY FOR CLOSINGS THAT WE CAN HANDLE FOR PURE EDGE AND PURE EDGE AGAIN IS JANUARY 31st 2009.

OKAY?

GRACE PERIOD APPLICATIONS WHICH THE GRANDERS KNOW IS WHERE IT'S CLOSED BUT CAN YOU ACCEPT APPLICATIONS AFTER THE CLOSING DATE. WE CAN ACCEPT THROUGH FEBRUARY 20.

AFTER FEBRUARY 20, AGENCIES CAN NO LONGER DOWNLOAD ANY PURE EDGE OPPORTUNITIES.

THAT'S THE FINAL SHUT OFF DATE.

OKAY THE TRANSITION TO ADOBE, THE AGENCIES CAN YOU SEE FROM THIS CHART, BY AND LARGE MOST OF THE AGENCIES HAVE TRANSIGGED OVER 2 ADOBE, EXCEPT FOR 4 AGENCIES WHICH BASICALLY USE THE RNR FORMS FAMILY, THEY'RE WAITING FOR THE CHAIRMANS TO COME AND THEN SPLIE THE CHAIRVELGS AND THEN THEY'LL COME ON OVER BY FEBRUARY 1. THE MAJOR AGENCY OF COURSE, ARE NSF, HHS, WHICH IS THE BIGGEST PARTNER THERE WOULD BE NIH, THE PARTNER OF DEPARTMENT OF AGRICULTURE AND THOSE ARE THE 4 AND THEY'RE ALL R& RR. OKAY, NOW THE TRANSITION FOR ADOBE FOR NIH, THIS IS A SPECIFIC FOR OUR--THIS IS REALLY FOR OUR APPLICANTS BECAUSE OVER HALF OUR APPLICATIONS COME IN FOR NIH AND THEY HAVE NOT TRANSITIONED OVER AND THANK YOU MY FRIENDS AT NIH. THEY GAVE ME THIS CHART THAT THEY USE SO YOU CAN SEE TODAY HOW THEY TRANSITION TO ADOBE WILL LOOK. THEY HAVE A PILOT THAT'S GOING TO--FOR AWE COUPLE OPPORTUNITIES OUT THERE IN OCTOBER, THEY ASK YOU TO CHECK FOR NEW OPPORTUNITIES IN DECEMBER AND AFTER JANUARY WITHIN, MOST OF THE OPPORTUNITIES WILL THEN BE IN ADOBE.

THEY WILL HAVE 2 OPPORTUNITIES OUT THERE, WELL ISSUES A HANDFUL OF SMALLER OPPORTUNITIES OUT THERE THAT WILL BE CLOSING IN JANUARY, AND OTHER THAN THAT, EVERYBODY--EVERYTHING ELSE BE GOING INTO ADOBE.

AND I THINK THIS CHART REALLY LAYS OUT THE TRANSITION FOR NIH AND THEN ALSO, THERE'S A NICE HYPER LINK ON THIS CHART WHICH GOES INTO FURTHER DETAIL WHICH I THINK I WENT THROUGH AND FOUND VERY USEFUL FOR MICE, SO IF--FOR MYSELF, SO IF ANYBODY HAS ADIGGAL QUESTIONS ABOUT THE NIH TRANSI, I THINK THAT IS HELPFUL. OKAY, MICHAEL?

ONE FOLLOW UP, YOU WERE TALKING A LOT ABOUT NIH IS BESIDES THE HYPER LINCH IN HERE AND HOW IS NIH COMMUNICATING THEIR TRANSITION? >> I BELIEVE THEY HAVE LIST SERVES OUT THERE THEY HAVE PUSHED OUT INFORMATION.

I KNOW THEY'VE GONE OUT AND THEY'VE BEEN COMMUNICATING THIS THROUGH VARIOUS MEAN AGAINS AND OF COURSE, THEIR WEB SITE.



I THINK THEY'VE DONE A PRETTY GOOD JOB TO KEEP THEIR APPLICANTS INFORMED AS THEY MOVED OVER.

THEY'VE DONE--THEY HAVE NEW SYSTEM TO SYSTEM OPPORTUNITIES UP FOR THEIR SYSTEM TO SYSTEM PEOPLE TO TEST ON THEIR SITE TOO, SO I THINK THEY'RE TRYING TO MOVE IN A VERY PRUDENT MANNER.

SO WHAT I WOULD LIKE TO TALK ABOUT NOW IS FOR THOSE WHO HAVE SUBMITTED APPLICATIONS OVER THE LAST 6 MONTHS, DO YOU EXPERIENCE SOME PAIN IN MAY AND JUNE?

WE HAD SYSTEM ISSUES.

WE ARE UNDERGOING 2--A 2 PHASE APPROACH TO CORRECT THAT.

PHASE 1 IS WHAT WE ARE REFERRING TO AS THE SPEED AND RELIABILITY, THIS IS SCHEDULED AND ONTARGET TO BE COMPLETED BY OCTOBER 282,008 IN A COUPLE OF WEEKS.

IN OS ENS WHAT WE'RE DOING HERE IS WE ARE INCLUDING 3 ADDITIONAL T-1 THOUSAND SERVERS WHICH ARE LARGE, LATEST AND GREATEST FULL CAPACITY.

WHAT WE'RE DOING WITH THOSE SERVERS ARE THE SOFTWARE THAT YOU--THAT IS UTILIZE TO EXECUTE THE SYSTEM, EXECUTE THOSE SERVERS IS CALLED WEB LOGIC AND SUN SO WE'RE USING THE LATEST VERSIONS OF WEB LOGIC AND SUN ON THOSE 3 SERVERS.

AS PART OF THE PHASE 1 APPROACH, THOSE 3 SERVERS ONCE THEY'RE BROUGHT ON LINE, WE ARE TAKING 2 OF OUR EXISTING SERVERS ISSUES TAKING THEM OFFLINE ADDING THOSE LATEST VERSIONS OF WEB LOGIC AND SUN ASK WILL PLACE THEM--AND WILL PLACE THEM ON LINE AS L. WE'RE ALSO INCREASE THE HARD DRIVE SPACE ON THOSE SERVERS SO ENDS DATE, OCTOBER 28th, THERE WILL BE 5 SERVERS WITH THE LATEST AND GREATEST TECHNOLOGY ON THERE.

WHAT DOES THAT MEAN IN TERMS OF NUMBERS, TODAYA WE SIT HERE OUR SYSTEM CAN PROCESS 2000 APPLICATIONS PER DAY.

SO FOR THOSE OF YOU WHO HAVE SUBMITTED ON LARGE CLOSING DAYS, LATE IN THE AFTERNOON, YOU WILL HAVE NOTICED THE SLOW PROCESS.

ONCE THIS SPEED AND RELIABILITY IS ACCOMPLISHED, OUR SYSTEM WILL HAVE BE ABLE TO PROCESS UPWARDS OF 10,000 APPLICATIONS.

NOW PHASE 1 TIES INTO THE PHASE 2.

PHASE 2 BEING OUR NEXT BUILD WHICH IS THE SCHEDULED FOR DECEMBER 13th, 2008.

THAT BUILD, THE MAIN FOCUS IS TO RECONFIGURE OUR LIGHT WEIGHT DIRECTORY ACCESS PROTOCOL WHICH STANDS FOR LDAPP, YOU LOOK AT IT WHEN GRANTORS AND APPLICANTS ACCESS OUR SYSTEM.

DEADA WE SIN HERE, WE-TODAY AS WE SIT HERE, WE CAN HAVE 360 USERS ON THE GRANTS.GOVERN SYSTEM, ONCE THE LDAPP IS RECONFIGURED WE WILL HAVE UPWARDS OF CONATURENT USERS.

SO, WE SIT HERE TODAY, WE CAN PROP SEASES, WE CAN HAVE 360 CONCURRENT USERS ON THIS SITE, PROCESSING 2000 APPLICATIONS. ON DECEMBER 14th, IF EVERYTHING GOES ACCORDING TO SCHEDULE AND PLAN

AND TEST SUGGEST SUCCESSFUL, OUR WILL BE ABLE TO HAVE 2000 CONCURRENT USERS PROCESSING UP TO 10,000 APPLICATIONS A DAY.

>> MICHAEL, YOU MENTIONED THE SPEED AND RELIABILITY IN THE LDAP RECONFIGURATION, DOES THIS MEAN THE APPLICATION WILL BE PROCESSED QUICKER OR WILL--WHAT WILL THE APPLICANTS--WILL THEY SEE INCREASEDDED SPEED?

>> YEAH, THEY WILL.

IF YOU'RE USING ADOBE FOR THOSE AGENCIES IN ADOBE, WHAT HAPPENS FOR THE APPLICANT, YOU'LL SEE THERE'S A STATUS BAR, THE PLU STATUS BAR AT THE BOTTOM OF YOUR SCREEN, IN ESSENCE YOU'LL SEE THAT SPEED UP, IT WON'T PUTTER ALONG LIKE IT'S BEEN DOING, SO THE SPEED ITSELF WILL INCREASE.

>> WELL THAT'S GOOD TO KNOW.

ONE OTHER THING AROUND THE BUILD, WHEN WE DID BUILD, WE DID BUILD 1 AND 2.

WE FROM THE COMMUNE KEYINGS TEAM, WE SEND--COMMUNICATIONS TEEM, WE ACCEPTED OUT A DETAILED COMMUNICATION EXPLAINING WHAT WAS, WHAT IS, AND WHAT OCCURRED AND WHAT CHANGED.

SO YOU LOOK FOR THAT AND WE'LL SHOW YOU THE LINK AT THE END. OF COURSE WE PUT IT ON THE WEB SITE AND WE'LL PUT IT ON THE BLOG BUT WE PROCESS THAT OUT THROUGH GRANT E-MAIL UPDATE THAT I'LL TALK ABOUT AT THE END OF TODAY'S PRESENTATION.

>> GOOD TO BE HERE, AND WITH THE GRANT COMMUNITY HERE TODAY, I WOULD LIKE TO TAKE THE OPPORTUNITY AND BRIEF YOU A BIT ABOUT THE CCR, THE CENTRAL CONTRACT REGISTRATION SYSTEMS AND HOW IT PLAYS A ROLE WITH THE GRANT COMMUNITY.

PRETTY MUCH CCR IS DESIGNED AS THE PRIMARY REGISTRANTS DATABASE FOR ANY GRANTEES TO BE ABLE TO ACTUALLY DO BUSINESS WITH THE FEDERAL GOVERNMENT.

OUR SYSTEM, IT'S WEB-ENABLE SYSTEM THAT CAN'SLY BE ACCESSED TO GO INTO WWW.CCR.GOV THAT'S PRETTY MUCH HOW YOU ACCESS OUR SYSTEM. WE DO THE NEXT 1, IN ADDITION TO THAT, WE ALSO NEED A POINT OF CONTACT INFORMATION, WHO'S YOUR--WHO'S GOING TO BE YOUR CENTRAL CONTRACT REGISTRATIONOT POINT OF CONTACT AND ALSO WHO IS GOING TO BE--WHO'S CURRENTLY YOUR GOVERNMENT BUSINESS POINT OF CONTACT, WE TYPICALLY WANT TO HAVE YOUR PRIME AIR SCHEALTERNATE FOR THAT TYPE OF INFORMATION AND ALSO WHO MANAGING YOUR EBIZ, YOUR ELECTRONIC BUSINESS BECAUSE ALL THESE PIECES ARE CRITICAL TO HOW HE MOVE FORWARD WITH REGISTRATION PROCESS.

AGAIN UNDER FINANCIAL SIDE, WE CERTAINLY GO AND NEED YOUR BANK CARD INFORMATION YOUR ABA INFORMATION AND YOUR ACCOUNT NUMBER, IF YOU DO USE AN AUTOMATED CLEARING HOUSE, WE CERTAIN LYE WANT TO KNOW THAT TO MAKE SURE THAT CERTAINLY THAT'S--MAKE SURE THAT WE CAN FUNNEL THE PAYMENT PROCESS CORRECTLY AND YOUR ACCOUNT RECEIVABLE POC ISSUES POINT OF CONTACT, WE WANT TO KNOW WHO THAT IS ALSO.
