# The Road Traveled May 28, 1971

 The development of the Essentials of an Accredited Educational Program for the Assistant to the Primary Care Physician was undertaken by the American Medical Association's Council on Medical Education's Advisory Committee on Education for Allied Health Professions and Services..

# **November 30, 1971**

- The AMA House of Delegates, with the endorsements noted and on recommendation of the Committee on Medical Education, adopted the Essentials,
- clearing the way for the approval of educational programs that met or exceeded these requirements.

# **December 18, 1971**

 Organizational meeting of the then-titled Joint Review Committee for Educational Programs for the Assistant to Primary Care Physician (JRC-PA).

## **June 1972**

 The JRC-PA made its first accreditation recommendations to the AMA.

### December 1976

 The AMA House of Delegates authorized the transfer of responsibility for accreditation from the AMA Council on Medical Education to its Committee on Allied Education and Accreditation (CAHEA)

#### 1988

 The JRC-PA was renamed the Accreditation Review Committee on Education for the Physician Assistant (ARC-PA).

#### March 1991 September 1991

- The AMA requested that administrative responsibility for the ARC-PA be undertaken by another sponsoring organization
- The corporate offices of the ARC-PA was established in Marshfield, Wisconsin

# 1994

 CAHEA was dissolved and accreditation activities were transferred to a new, independent agency, the Commission on Accreditation of Allied Health Education Programs (CAAHEP).

#### March 2000

 The members of the ARC-PA voted to become a freestanding accrediting agency for the PA profession as of January 1, 2001.

#### What do accrediting agencies do?

 Grant public recognition to an institution or specialized program of study that meets or exceeds nationally established standards of acceptable educational quality

#### ARC-PA

#### Mission Goals

- recognized accrediting agency that protects the interests of the public, current and prospective PA students, and PA profession by defining the standards for PA education and evaluating PA educational programs within the territorial United States to ensure their compliance with those standards.
- Foster excellence in PA programs by requiring continuous self-study and review
- To ensure that education provided by institutions of higher education meets or exceeds acceptable levels of quality
- Provide information and guidance to individuals, groups, and organizations regarding PA program accreditation

#### Geographic Scope

 The ARC-PA only accredits qualified PA programs offered by, or located within, institutions chartered by, and physically located within the United States, and where students are geographically located within the United States for their education.

- > Avoid conflict of interest
- > Due Process Fair Treatment

#### Purpose of Standards

The Standards outline the requirements to which an accredited program is accountable.


