1. System Information. Describe the system - include system name, system acronym, and a description of the system, to include scope, purpose and major functions.

The Migrant Student Information Exchange (MSIX) supports the Migrant Education Program (MEP), which is administered by the Office of Migrant Education (OME) under the Office of Elementary and Secondary Education (OESE). The MEP supports State Educational Agencies (SEAs) by providing funding to help SEAs establish or improve educational programs for migrant students. MSIX has been developed to provide an effective method for electronically exchanging student records amongst States; and, to determine an accurate count of the number of migratory children in each State. As such, MSIX provides a means for States to coordinate information sharing for the migrant student community.

2. Legal Authority. Cite the legal authority to collect and use this data. What specific legal authorities, arrangements, and/or agreements regulate the collection of information?

MSIX is authorized under section 1308(b)(2) of the ESEA, as amended by the No Child Left Behind Act of 2001 (20 U.S.C. Section 6398(b)(2)).

3. Characterization of the Information. What elements of PII are collected and maintained by the system (e.g., name, social security number, date of birth, address, phone number)? What are the sources of information (e.g., student, teacher, employee, university)? How is the information collected (website, paper form, on-line form)? Is the information used to link or cross-reference multiple databases?

The categories of records in the system include the migrant child's: Name, date of birth, personal identification numbers assigned by the States and the Department, parent's or parents' name or names, school enrollment data, school contact data, assessment data, and other educational and health data necessary for accurate and timely school enrollment, grade and course placement, and accrual of course credits. The final request for public comment on the minimum data elements (MDEs) to be included in MSIX was published, pursuant to the Paperwork Reduction Act of 1995 clearance process, in the **Federal Register** on August 3, 2007 (72 FR 43253-34). 4. Why is the information collected? How is this information necessary to the mission of the program, or contributes to a necessary agency activity. Given the amount and any type of data collected, discuss the privacy risks (internally and/or externally) identified and how they were mitigated.

The purpose of MSIX is to enhance the continuity of educational and health services for migrant children by providing a mechanism for all States to exchange educational and health related information on migrant children who move from State to State due to their migratory lifestyle. It is anticipated that the existence and use of MSIX will help to improve the timeliness of school enrollments, improve the appropriateness of grade and course placements, and reduce incidences of unnecessary immunizations of migrant children. Further, MSIX will facilitate the accrual of

course credits for migrant children in secondary school by providing accurate academic information on the student's course history and academic progress.

MSIX does not collect Social Security Numbers.

The information will be used to facilitate the timely enrollment, grade and course placement, and credit accrual of migrant students who move from one district or State to another due to their migrant lifestyle.

MSIX will not share personally identifiable information with internal ED organizations
