### **Abstract**

The Emergency Management Response System (EMRS) is a Major Application used by the APHIS Veterinary Services (VS) to manage and investigate animal disease outbreaks in the United States. The system is used by Federal, State, Tribal, and local animal health officials and human health officials. This Privacy Impact Assessment (PIA) is being completed following the Privacy Threshold Analysis (PTA) conclusion requiring a PIA for EMRS to meet federal privacy compliance requirements.

### Overview

The Emergency Management Response System (EMRS) records information resulting from all foreign animal disease investigations and provides incident management. EMRS supports APHIS VS timely and effective responses to manage animal health emergencies by automating the collection, management, and analysis of data from animal disease investigations and animal disease outbreak incidents. EMRS is used by the Veterinary Service (VS) to manage and investigate animal disease outbreaks in the United States. EMRS is a Web-based task management system accessed by approved users using Microsoft Internet Explorer, and includes Geographic Information System (GIS) mapping support for easy visualization of work areas. Primary users of EMRS are Federal and State veterinary medical officers, animal health technicians, and various disease specialists and epidemiologists from APHIS and from State cooperators. In an animal disease emergency, VS could potentially enlist the assistance of more than 40,000 federally accredited private veterinary practitioners who assist with disease exclusion, detection, and control. The system allows users to view data, create reports and create maps of specific areas.

### Section 1.0 Characterization of the Information

The following questions are intended to define the scope of the information requested and/or collected as well as reasons for its collection as part of the program, system, rule, or technology being developed.

## 1.1 What information is collected, used, disseminated, or maintained in the system?

Information includes name; address (including city), county, State, postal code, latitude/longitude coordinates; premises identification number; and telephone number. The EMRS may also contain the name and telephone number of the person(s) who provided the initial report concerning the premises, and the name, telephone number, and e-mail address of the person responsible for the investigation of the premises. EMRS also contains information about APHIS employees who may be deployed as members of Incident Command System (ICS) teams.



### 1.2 What are the sources of the information in the system?

Owner or operator of the premises where the animal(s) subject to investigation are located and APHIS VS employees, referring contact, and case coordinator.

### 1.3 Why is the information being collected, used, disseminated, or maintained?

Data is used by the VS to manage and investigate animal disease outbreaks in the United States. The system is used by Federal, State, Tribal, and local animal health officials (and human health officials) for:

- Routine reporting of Foreign Animal Disease (FAD) investigations
- Surveillance and control programs
- State-specific disease outbreaks
- National animal health emergency responses

#### 1.4 How is the information collected?

State and local VS and Veterinary Officers and various disease program laboratories provide data for use in EMRS, depending upon the geographic extent of the particular animal disease outbreak, and dependent upon if an appropriate data sharing Memorandum Of Understanding (MOU) is in place with USDA. The mapping module occasionally utilizes public data from the U.S. Geological Survey and other Federal resources available to the public.

#### 1.5 How will the information be checked for accuracy?

Authorized federal, state, or temporary EMRS personnel that collect and enter the data are responsible for the review and accuracy of the data. Information is obtained from either a customer or an employee and is often supplemented during an investigation by on-site visits, USPS database for address-validation (via the internal VS Animal Disease Traceability Information System (ADTIS) Allocator application). There are also limited data entry constraints to ensure entry completeness. APHIS employees also have access to the EMRS Administrative module where they may edit and maintain their own employee profiles. EMRS updates Employee Profiles via records in the Emergency Qualification System (EQS) and this is done nightly (EQS gets their data from the National Finance Center (NFC) bi-weekly).

### 1.6 What specific legal authorities, arrangements, and/or agreements defined the collection of information?

APHIS is an emergency response organization whose mission is to protect the health and value of U.S. agricultural, natural and other resources.



The Animal Health Protection Act (AHPA) (7 U.S.C. 8301 et seq.) provides the authority for the Secretary to prevent, detect, control, and eradicate diseases, and pests of birds and other livestock to protect animal health, the health and welfare of people, economic interests of livestock and related industries, the environment, and interstate and foreign commerce in birds, other livestock, and other articles.

Any additional authority comes from the specific state under which investigation is occurring.

## 1.7 <u>Privacy Impact Analysis</u>: Given the amount and type of data collected, discuss the privacy risks identified and how they were mitigated.

Privacy rights of the customer and employees will be protected by USDA, APHIS and VS management.

- All access to the system is limited by username/password.
- Application limits access to relevant information and prevents access to unauthorized information.

Data is secured by means of encryption and access control. Access is controlled by:

- · User ID and password
- Access Control List
- Read and write authorization permissions that are specific to individual EMRS electronic forms
- Location-specific servers

EMRS also uses Lotus Notes role based access control to restrict who can enter key disease control information. The VS management team, Emergency Program (EP) staff, and Regional Directors will determine when data needs to be consolidated and ensure data is protected from unauthorized access or use based on user roles as well.

### Section 2.0 Uses of the Information

The following questions are intended to delineate clearly the use of information and the accuracy of the data being used.

#### 2.1 Describe all the uses of information.

Data is used by VS to manage and investigate animal disease outbreaks in the United States. The system is used by Federal, State, Tribal, and local animal health officials (and human health officials) for:

• Routine reporting of Foreign Animal Disease (FAD) investigations



- Surveillance and control programs
- State-specific disease outbreaks
- National animal health emergency responses

When other Federal and State emergency response agencies assist USDA with an emergency disease outbreak, they may be allowed limited access to the data in EMRS. The access will depend upon the MOU in place and the need to know of the other agency. Data will be used for:

- Routine reporting of FAD investigations
- Surveillance and control programs
- · State-specific disease outbreaks
- National animal health emergency responses

## 2.2 What types of tools are used to analyze data and what type of data may be produced?

Data from EMRS is spatially enabled to another server running Oracle to provide data for the GIS mapping component of EMRS. Only the data needed for the mapping module is put into Oracle tables as a backend relational extension of EMRS. Testing laboratories will also be receiving limited data elements when samples are submitted to the lab for testing and will provide test results for samples submitted back to EMRS. EMRS data may eventually be housed in a data warehouse. Once developed; data access in the data warehouse will be managed with the same rules as EMRS.

## 2.3 If the system uses commercial or publicly available data please explain why and how it is used.

EMRS has layers that are shape or raster files that can be overlaid in the mapping module on maps of premises-based information that contain public data such as Cities, Interstates, Rivers, Public lands, etc. These are all available free for either download or thru web services from USGS as well as other sources. They are used to give context to the data displayed from the premises-based information in EMRS.

## 2.4 <u>Privacy Impact Analysis</u>: Describe any types of controls that may be in place to ensure that information is handled in accordance with the above described uses.

Data is secured by means of encryption and access control. Access is controlled by:

- User ID and password
- Access Control List
- Read and write authorization permissions that are specific to individual EMRS electronic forms
- Location-specific servers



EMRS also uses Lotus Notes role based access control to restrict who can enter key disease control information. The VS management team, Emergency Program (EP) staff, and Regional Directors will determine when data and/or processes need to be consolidated and will ensure the data is protected from unauthorized access or is used based on user roles.

### Section 3.0 Retention

The following questions are intended to outline how long information will be retained after the initial collection.

### 3.1 How long is information retained?

Routine FAD data from EMRS is expected to be retained on the server for an indefinite time until the actual records retention scheduled is approved by NARA. Employee data is maintained as long as employee is employed and may be maintained for up to 5 years after employment ceases in case employee is re-employed during emergencies. After an animal outbreak data is retained a minimal of 20 years for an active record, and 10 years for inactive records.

## 3.2 Has the retention period been approved by the component records officer and the National Archives and Records Administration (NARA)?

No. Records retention in this application has not specifically been approved by NARA.

## 3.3 <u>Privacy Impact Analysis</u>: Please discuss the risks associated with the length of time data is retained and how those risks are mitigated.

Risks associated with data retention are minimal and include the possibility of the data being accessed by unauthorized personnel. EMRS uses role based access to mitigate this risk. The VS management team, EP staff, Regional Directors, Accredited Veterinarian In Charge (AVIC), State Veterinarians and EMRS team members and authorized users are all responsible for protecting the privacy rights of the customers and employees affected by the interface. The Login interface reminds users of their responsibility every time they log in.

### Section 4.0 Internal Sharing and Disclosure

The following questions are intended to define the scope of sharing within the United States Department of Agriculture.



## 4.1 With which internal organization(s) is the information shared, what information is shared and for what purpose?

EMRS does not routinely share data with any USDA organization. However, in case of emergency disease outbreak internal agencies maybe allowed limited access to the data in EMRS as indicated in Section 5 of PIA.

#### 4.2 How is the information transmitted or disclosed?

The data will be retrieved through selection queries to:

- View data
- Create reports
- Create maps of specific areas

Data can be retrieved only by personnel who have logged in with a user ID and password issued by APHIS personnel. If data is retrieved via the Notes client, no record of data queried is kept but individual must have user access and rights to access data. Data can be retrieved by a full text search or a defined search. The full text search allows any data matching the entered data element to be retrieved. In the Investigation module, defined search data can be retrieved by: Premises ID, Reference Control Number, Premises Name, Incident Group, or Incident Site. In the Administration module, defined search data can be retrieved by: employee, property, fleet vehicle, ledger, last name, first name, employee ID, nickname, title, organization, or section.

## 4.3 <u>Privacy Impact Analysis</u>: Considering the extent of internal information sharing, discuss the privacy risks associated with the sharing and how they were mitigated.

In emergency disease outbreak situations where internal agencies assist EMRS with management activities, there is a potential for information to be shared with unauthorized users. It is the intent of EMRS that the uses of information remain in accordance with the stated purpose and use of the original collection at all times. Steps will be taken to ensure that access to the information system is provided only to authorized users. Data will be used by USDA Federal and State FADDs, the laboratories, and animal health officials to document, manage, and communicate activities and findings while conducting routine foreign animal disease investigations.

### Section 5.0 External Sharing and Disclosure

The following questions are intended to define the content, scope, and authority for information sharing external to USDA which includes Federal, state and local government, and the private sector.



## 5.1 With which external organization(s) is the information shared, what information is shared, and for what purpose?

When other Federal and State emergency response agencies assist USDA with an emergency disease outbreak, they may be allowed limited access to the data in EMRS. The access will depend upon the MOU in place and the need to know of the other agency. As an example, during Incident Management Response efforts, data may be shared the Food and Drug Administration, the Department of Homeland Security, or an applicable state Department of Agriculture. Data will be used for:

- Routine reporting of FAD investigations
- Surveillance and control programs
- State-specific disease outbreaks
- National animal health emergency responses
- 5.2 Is the sharing of personally identifiable information outside the Department compatible with the original collection? If so, is it covered by an appropriate routine use in a SORN? If so, please describe. If not, please describe under what legal mechanism the program or system is allowed to share the personally identifiable information outside of USDA.

The uses of information are in accordance with the stated purpose and use of the original collection. Data will be used by VS Federal and State FADDs, the laboratories, and animal health officials to document, manage, and communicate activities and findings while conducting routine foreign animal disease investigations

5.3 How is the information shared outside the Department and what security measures safeguard its transmission?

The data will be retrieved through selection queries to:

- View data
- Create reports
- Create maps of specific areas



Data can be retrieved only by personnel who have logged in with a user ID and password issued by APHIS personnel. If data is retrieved via the Notes client, no record of data queried is kept but individual must have user access and rights to access data. Data can be retrieved by a full text search or a defined search. The full text search allows any data matching the entered data element to be retrieved. In the Investigation module, defined search data can be retrieved by: Premises ID, Reference Control Number, Premises Name, Incident Group, or Incident Site. In the Administration module, defined search data can be retrieved by: employee, property, fleet vehicle, ledger, last name, first name, employee ID, nickname, title, organization, or section.

## 5.4 <u>Privacy Impact Analysis</u>: Given the external sharing, explain the privacy risks identified and describe how they were mitigated.

The uses of information are in accordance with the stated purpose and use of the original collection. Data will be used by VS Federal and State FADDs, the laboratories, and animal health officials to document, manage, and communicate activities and findings while conducting routine foreign animal disease investigations.

### Section 6.0 Notice

The following questions are directed at notice to the individual of the scope of information collected, the right to consent to uses of said information, and the right to decline to provide information.

## 6.1 Was notice provided to the individual prior to collection of information?

## 6.2 Do individuals have the opportunity and/or right to decline to provide information?

Yes. There is no penalty at the federal level if user refuses to provide information. Any consequences are enforced at the state level.

## 6.3 Do individuals have the right to consent to particular uses of the information? If so, how does the individual exercise the right?

Yes. Information is collected only for specified circumstances or investigation, and this information is not utilized for any other purpose other than for those collected. Use of data is limited to the use for which it was collected and ERMS staff does not release information unless there is an over-riding reason.



## 6.4 <u>Privacy Impact Analysis</u>: Describe how notice is provided to individuals, and how the risks associated with individuals being unaware of the collection are mitigated.

The System of Record Notice is the official notice. Also, notice is also given via the EMRS Privacy Banner and Memorandum Of Understandings (MOU) with other Organizations.

### Section 7.0 Access, Redress and Correction

The following questions are directed at an individual's ability to ensure the accuracy of the information collected about them.

## 7.1 What are the procedures that allow individuals to gain access to their information?

Any individual may obtain information from a record in the system that pertains to him or her. Requests for hard copies of records should be in writing, and the request must contain the requesting individual's name, address, name of the system of records, timeframe for the records in question, any other pertinent information to help identify the file, and a copy of his/her photo identification containing a current address for verification of identification. All inquiries should be addressed to the Freedom of Information and Privacy Act Staff, Legislative and Public Affairs, APHIS, 4700 River Road Unit 50, Riverdale, MD 20737-1232

### 7.2 What are the procedures for correcting inaccurate or erroneous information?

Inaccurate data are corrected by submitting requests to USDA APHIS Veterinary Services employees, state employees and or other federal employees and approval is required in order for corrections to be made.

## 7.3 How are individuals notified of the procedures for correcting their information?

Individuals are notified of procedures at the point of data collection.

## 7.4 If no formal redress is provided, what alternatives are available to the individual?

Any individual may contest information contained within a record in the system that pertains to him/her by submitting a written request to the system manager to the



Freedom of Information and Privacy Act Staff, Legislative and Public Affairs, APHIS, 4700 River Road Unit 50, Riverdale, MD 20737-1232. Include the reason for contesting the record and the proposed amendment to the information with supporting documentation to show how the record is inaccurate.

7.5 <u>Privacy Impact Analysis</u>: Please discuss the privacy risks associated with the redress available to individuals and how those risks are mitigated.

Once received by the VS the requests to correct information are treated as sensitive material in accordance with the formal redress methods. Any data used or furnished to others would need to be cleared through the Freedom of Information Act process.

### Section 8.0 Technical Access and Security

The following questions are intended to describe technical safeguards and security measures.

8.1 What procedures are in place to determine which users may access the system and are they documented?

Access to EMRS is based on Need-to-know and role-based access.

8.2 Will Department contractors have access to the system?

No

8.3 Describe what privacy training is provided to users either generally or specifically relevant to the program or system?

All USDA APHIS VS employees are required to complete Privacy and Security Training.

8.4 Has Certification & Accreditation been completed for the system or systems supporting the program?

Yes – System accreditation expired in 2011. A new C&A is in progress.

8.5 What auditing measures and technical safeguards are in place to prevent misuse of data?

Formal auditing measures for the EMRS will include security assessments performed by APHIS at least annually and independent security assessments performed in support of Certification and Accreditation efforts. The independent assessments will be performed per the timeframe of EMRS re-certification.



#### As to technical safeguards:

- The EMRS is continuously monitored in several different ways. The APHIS
   Enterprise Infrastructure General Support Services (AEI GSS) staff performs a
   monthly scan of all servers to identify possible vulnerabilities. The results are
   provided to the VS CIO Technology staff for action. The vulnerabilities
   identified are required to be remediated by the responsible parties.
- Security related incidents are reported to the ISSM and requires an investigation. APHIS Cyber Incident Response Team (ACIRT) and USDA Agriculture Security Operations Center (ASOC) work together to respond and handle all incidents.
- Operational technical safeguards to prevent data misuse begin with access control. Access to EMRS information is protected by group-based access which is managed by the network firewall, and Lotus Notes authentication. Users must have a government issued login and password that is controlled and managed either at the Veterinary Services CIO office or the AEI GSS level. Password controls, procedures, responsibilities and policies follow USDA departmental standards. At most sites, responsibility and scope of data access is defined by users' job descriptions. Policy dictates that a user may not 'self-nominate' themselves for access. Requests for access must come from their supervisor or other authorized animal health official.

Data can be retrieved by a full text search or a defined search. The full text search allows any data matching the entered data element to be retrieved. In the Investigation module, defined search data can be retrieved by: Premises ID, Reference Control Number, Premises Name, Incident Group, or Incident Site. In the Administration module, defined search data can be retrieved by: employee, property, fleet vehicle, ledger, last name, first name, employee ID, nickname, title, organization, or section.
