## **MESSAGE FROM THE PMO**

Grants.gov is pleased to be nearing deployment of the 2007 Grants.gov system and appreciates the participation and patience of our agency and applicant users. We are planning a phased deployment.

Our original schedule has been extended to improve the end-user experience with the system. We are also incorporating additional feedback from our Section 508 testing and the recent agency and applicant testing to improve the usability of the system and application forms. Most importantly, we are improving integration with the existing system during the transition period. This has a number of benefits:

- Agencies that have already posted application packages in PureEdge do not need to immediately replace them with Adobe forms packages;
- Applicants use a single link to click to apply regardless of whether an application package was posted with PureEdge or Adobe forms;
- Applicants that have downloaded and completed application packages with PureEdge forms can submit them unchanged through the transition period; and
- Agencies and applicants get a consolidated view of applications that includes applications submitted to the old system as well as the new system.

The core system functions, from agency posting through application submission and agency receipt, have been acceptance tested and will be deployed soon. A core set of forms has also been acceptance tested and will be redeployed with the remaining forms incorporating the feedback from the testing with additional system capabilities over a phased period. Meanwhile, the additional integration described above will allow agencies and applicants to continue using the system without disruption.

We are excited about the capabilities of the new system, including improved opportunity search and better cross-platform support using Adobe forms. Check the Grants.gov website for regular schedule updates.

## **THE FEDERAL FUNDING ACCOUNTABILITY AND TRANSPARENCY ACT (FFATA)**

FFATA, enacted on September 26, 2006, requires the Office of Management and Budget (OMB) to make available online, a database that allows users to search all Federal funds awarded to an entity by fiscal year.

During the April Grants.gov Stakeholder Webcast, Terry Hurst, Deputy Assistant Secretary at the Department of Health and Human Services and Subcommittee Chair for the FFATA work-group on grants, reviewed the requirements for the upcoming FFATA deadlines.

## **MANAGING PARTNER**



*Fulfilling the President's  
Management Agenda*

The Act requires OMB to ensure the existence and operation of a website that provides the public with easy access to information about Federal expenditures. It does not include payments to individuals. The data elements required in the bill for each transaction include:

- The amount;
- Information including transaction type, funding agency, the North American Industry Classification System code or Catalog of Federal Domestic Assistance number (where applicable), program source, and an award title descriptive of the purpose of each funding action;
- The name and location of the recipient and the primary location of performance; and
- A unique identifier for the recipient and any parent entity.

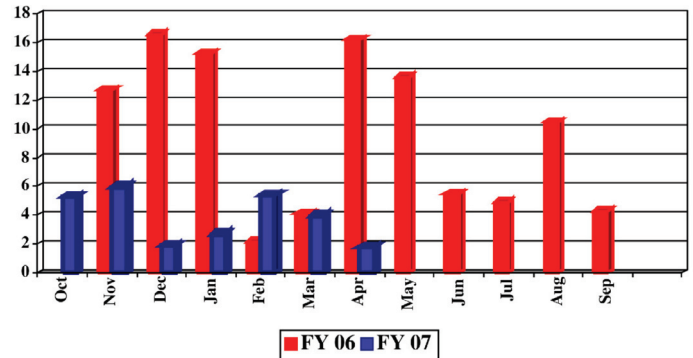
### GRANTS POLICY COMMITTEE AND FEDERAL GRANT STREAMLINING

### CONTACT CENTER UPDATE

As always, the experts at the Grants.gov Contact Center stand ready to assist you with your questions about finding and applying for Grants. As enhancements – such as new forms and enhanced search functionality – are made to the website, the Contact Center increases staffing to stay on top of any influx in emails or calls that these changes may bring. Staffing is also ramped up to meet the surge on days when there are a large number of agency grant closings.

Abandoned Rate



In the month of April 2007, the Contact Center met the abandoned call rate performance goal every day. The abandoned rate is the percentage of callers who disconnect prior to speaking with a customer service representative. The goal is 5%.

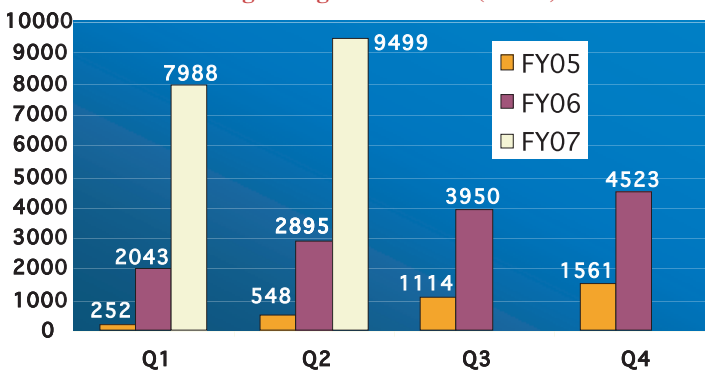

## AGENCY STATUS AND PARTICIPATION

Since it first went live in October 2003, Grants.gov has grown from a first-year record of 17 agencies with 1,140 submissions to 26 agencies and over 90,000 submissions in FY 2006. For FY 2007 through May 8th the total number of submissions is 101,281. During this time, Grants.gov has continually implemented technologies to improve the grantor and grantee experience. With continuing input from the entire grant community, the Grants.gov Program Management Office looks forward to even greater accomplishments in the future.
