Turning Pain into Action: Youth Violence Prevention Takes Center Stage as Six Cities Unveil their Plans

The Center for Faith Based & Neighborhood Partnerships at the Department of Justice was pleased to join other federal partners on Monday, April 4th –April 5th in Washington, D.C., along with teams from Boston; Chicago; Detroit; Memphis; Salinas, Calif.; and San Jose, who have been part of the National Forum on Youth Violence Prevention. At this great event the six cities unveiled their comprehensive youth violence prevention plans.

In addition to the Mayors, Chiefs of Police, Superintendents of Schools and US Attorney's from these six cities a number of Faith and Community Based representatives participated as well.

On Monday, April 4th, U.S. Department of Education, Secretary of Education Arne Duncan; ONDCP Director Gil Kerlikowske; and Members of Congress spoke to the attendees, along with the Rev. Gregory J. Boyle, S.J., founder of Homeboy Industries and the Rev. Samuel "Billy" Kyles, one of few people with Rev. Dr. Martin Luther King, Jr. at the time of his assassination.

Joshua DuBois, the Executive Director of the White House Office of Faith Based & Neighborhood Partnerships moderated a panel called "Turning Pain into Action: The Killing Must Stop". This panel put a human face on youth violence. Panel members discussed how real life experiences inspired them to become actively involved in making their communities safer. Panelists included:
