2. **Nature and/or description of the action:**

This is a sole source procurement of a reoccurring annual electronic subscription to the scientific and policy publications *Greenwire*, *E&E News* and *Landletter* from E&E Publishing. The Agency has procured this electronic subscription for multiple years to provide Agency users with access on their desktop. The service provides Agency scientist, regulatory and technical staff with essential information for policy, scientific and research determinations. Failure to extend this task order would disrupt EPA's ability to respond in an effective and timely manner to the research and regulatory needs of the Agency for policy and scientific determinations. This procurement is consistent with the Agency's top seven priorities to protect human health and safeguard the natural environment.

3. **Description of the Supplies or Services:**

OEI manages access to information on the Agency's Intranet site. This service is an on-line subscription to the scientific and policy publication *Greenwire*, *E&E News* and *Landletter*. E & E Publishing, LLC, will provide access to their exclusive publication on-line via the Internet to four umbrella EPA Internet Protocol (IP) addresses that provide access to all Agency staff and on-site contractors.

At this time, E & E News, LLC has not released the rights for the electronic submission of its electronic publication to any other publisher or distributor.
