COMMISSION ANNOUNCEMENTS

COMMISSION INVITES BRIEFS ON PRESENT STATUS OF PROCEEDINGS INSTITUTED UNDER FORMER SECTION 15(b)(7) OF THE SECURITIES EXCHANGE ACT

Until June 4, 1975, the Securities Exchange Act expressly authorized the Commission to conduct administrative proceedings thereunder against and to impose remedial sanctions on "any person". The pertinent section of the Exchange Act was former Section 15(b) (7). That section has now been modified. The Securities Amendments Act of 1975, which became law on June 4: (a) repealed former Section 15(b) (7); (b) replaced it by present Section 15(b) (6); and (c) substituted the phrase "any person associated, or seeking to become associated, with a broker or dealer" for the former words "any person."

That raises questions as to the present status of cases instituted under the Exchange Act, as it stood before June 4, against people who are not alleged to have been broker-dealers, or persons associated with broker-dealers, or persons seeking to become so associated. Some such respondents have already moved for dismissal on the ground that they are now immune from further proceedings.

Stating that those motions "raise significant questions" and that quite apart from them, it does not want to proceed with steps that it has no power to take, the Commission has called for briefs on the impact, if any, of the new statute on cases brought under former Section 15(b)(7). That invitation is not limited to the affected respondents. On the contrary, anyone who wishes to state views on the questions presented is asked to do so.

The Commission's order states that "such briefs may advert to any considerations that their authors deem pertinent." However, the order goes on to identify issues on which comments would be especially appreciated.

Memoranda on these questions and on others that anyone consider pertinent to the issues raised by this statutory change may be filed at any time on or before August 4, 1975. Such memoranda must show proof of service on the Commission's Division of Enforcement. The memorandum of an affected respondent in a specific proceeding should bear the caption of that proceeding. Memoranda filed by others should be captioned "in the Matter of A. P. Montgomery & Co., Inc., et al., Administrative Proceeding File No. 3-4424."

Reply memoranda with proof of service will be due on September 5, 1975. All persons filing memoranda should be sure to file the original and seven copies with the Commission's Secretary. (Rel. 34-11501)

REQUEST FOR RECOMMENDATIONS FOR APPOINTMENT TO THE NATIONAL MARKET ADVISORY BOARD

The SEC today announced that it is requesting recommendations of individuals for appoint appointment to the National Market Advisory Board whihe Congress has directed it to establish. The Board will furnish its views to the Commission on significant regulatory proposals; study and make recommendations to the Commission as to appropriate steps to facilitate the establishment of a national market system; and study the possible need for modification of the existing scheme of self-regulation so as to adopt it to a national market system. WILLARD G. BERGE BARRED

Administrative Law Judge David J. Markun has issued an initial decision barring Willard G. Berge, of Minneapolis, Minnesota, from association with a broker or dealer with the proviso that after a period of 6 months he may apply to become associated with a registered broker or dealer in a non-proprietary, non-supervisory capacity upon a satisfactory showing to the Commission that he will be adequately supervised.

The sanction was imposed on the basis of findings that Berge, in selling certain securities on behalf of Vande Vagte, Inc., then a Minneapolis, Minnesota broker-dealer, during the period from about October 1, 1970 to August 1, 1972, (a) wilfully aided and abetted Vande Vagte, Inc.'s violations of the registration requirements of Subsection 5(a) and 5(c) of the Securities Act and (b) wilfully violated, and wilfully aided and abetted Vande Vegle, Inc.'s violations of the antifraud provisions of Section 17(a) of the securities laws.

The securities involved were unregistered assignments of deferred-payments lot-purchase contracts and promissory notes of New Life Trust, Inc., an Arizona land development corporation controlled by Cadmus L. G. Goss that attempted to develop a subdivision near Dateland, Arizona, but went bankrupt before the development could be carried out.

The decision is subject to review by the Commission on its own motion or on petition of a party.

ROBERT E. FEENEY, HARVEY L. VELGERS DYK, AND JOHN R. PATTERSON BARRED

Administrative Law Judge David J. Markun has issued an initial decision barring Robert E. Feeney, Harvey L. Velgersdyk, and John R. Patterson, residents of Iowa, from association with a broker or dealer with the proviso that after a period of 1 year they may apply to become associated with a registered broker or dealer in a non-proprietary, non-supervisory capacity upon a satisfactory showing to the Commission that they will be adequately supervised.

The sanctions were imposed on the basis of findings that Feeney, Velgersdyk, and Patterson, in selling certain securities on behalf of Kirsch, Chandler, Feeney & Co., Incorporated, then an Iowa broker-dealer with principal offices in Des Moines, within the period from about October 1971 until about July 1972, (a) wilfully aided and abetted Kirsch, Chandler's violations of the registration requirements of Subsections 5(a) and 5(c) of the Securities Act and (b) wilfully violated, and wilfully aided and abetted Kirsch, Chandler's violations of, the antifraud provisions of Section 17(a) of the securities laws.

The securities involved were unregistered assignments of deferred-payment lot-purchase contracts and promissory notes of New Life Trust, Inc., an Arizona land development corporation controlled by Cadmus L. G. Goss that attempted to develop a subdivision near Dateland, Arizona, but went bankrupt before the development could be carried out.

The decision is subject to review by the Commission on its own motion or on petition of a party.

COURT ENFORCEMENT ACTIONS

ORVIS BROS. & CO. DEFENDANTS SENTENCED

The New York Regional Office announced that on June 16 the Honorable Whitman Knapp, Federal Court District Judge for the Southern District of New York, sentenced Fergus M. Sloan, Jr., Thomas C. Kilduff and Donald Eucker each to imprisonment for one year and one day. Judge Knapp also sentenced Thomas Kilduff to probation for a period of three years. The defendants were former officers of Orvis Bros. & Co., a now defunct member of the New York Stock Exchange. Sloan and Kilduff were sentenced on their pleas to conspiracy to violate the securities laws; Anderson on his conviction after a jury trial of conspiracy and Eucker on his guilty plea to the charge of illegal hypothecation of fully paid customers' securities. (U.S. v. Sloan, Jr., et al.). (LR-6951)

SANITAS SERVICE CORPORATION

The SEC announced that on June 24 Judge Howard F. Corcoran, U.S. District Court Judge for the District of Columbia, entered a judgment in SEC v. Sanitas Service Corporation, et al., permanently enjoining defendant Sanitas Service Corporation (Sanitas) from violating the antifraud, reporting, and proxy solicitation provisions of the securities laws.

The Court's decree enjoins Sanitas from issuing and disseminating to its shareholders and the investing public and filing and causing to be filed with the Commission false and misleading annual and periodic reports, proxy materials, press releases, registration statements and prospectuses. More specifically, the decree enjoins Sanitas from failing to disclose the nature and extent of expenditures of corporate funds for political payments, bribes, kickbacks, or other unlawful purposes, from making or causing to be made false entries in books and records for the purpose of concealing secret payments, and from establishing or maintaining a fund or conduit for paying monies for political payments, bribes, kickbacks or other similar unlawful purposes.

In addition, the injunction prohibits Sanitas from improperly accounting for acquisitions of businesses or assets as poolings of interest and from treating as discontinued operations lines of business which are still operated by Sanitas, and that Sanitas amend prior filings with the Commission.

The injunctive decree also provides that Sanitas shall maintain audit and legal committees comprised of members of its Board of Directors to review reports to be prepared by Sanitas' new outside general counsel and auditors of investigations of illicit cash payments during 1969 to the present, conflicts of interest questions, the purchase and sale by Sanitas of certain businesses, and employment and consulting contracts.

Sanitas consented to the entry of the judgment and order of permanent injunction and ancillary relief without admitting or denying the allegations in the complaint. (SEC v. Sanitas Service Corporation, et al., D.D.C.). (LR-6952)

HILLIARD CROWN PLEADS GUILTY

Victor Ortega, U.S. Attorney for the District of New Mexico, and the Denver Regional Office announced that on June 20 Hilliard Crown, a Santa Fe, New Mexico accountant, pleaded guilty to a cound charging him with submitting a false statement of his financial condition to the First National Bank of Santa Fe, New Mexico in connection with a loan made by that bank to Crown in violation of the federal banking laws.

Previously, defendant Crown, along with others, had been indicted by a federal grand jury in a multi-count indictment charging securities fraud, mail fraud, misapplication of bank funds and wire fraud in connection with the activities of American Fuels Corporation and affiliated corporations.

Sentencing is scheduled for a later date before U.S. District Judge H. Vearle Payne of the District of New Mexico. (U.S. v. E. M. (Mike) Riebold, et al., U.S.D.C., District of New Mexico, Criminal No. 74-353). (LR-6953)

CONSOLIDATED NATURAL GAS COMPANY

A notice has been issued giving interested person until July 21 to request a hearing on a proposal of Consolidated Natural Gas Company, a registered holding company, to acquire as a wholly-owned subsidiary corporation, CNG Research Company, a newly created Delaware corporation. Consolidated will acquire in 1975, for \$2,500,000 cash, 25,000 shares of CNG Research's common stock, (\$100 par), and during each of the years 1976-1979, 6,000 such shares for \$600,000. Consolidated will transfer to CNG Research four proprietary research contracts presently administered by Consolidated Natural Gas Research Company. (Rel. 35-19065 - June 26)
