#### ENFORCEMENT PROCEEDINGS

### MUTUAL FUND CHARGES DISMISSED

Charges against Richard Hoffman of Palm, Pa., and Kirk Montgomery, formerly of FSC Securities of Atlanta, Ga., were dismissed after a hearing before an administrative law judge. Hoffman had been charged with violating the antifraud provisions of the securities laws in connection with the sale of mutual funds, and Montgomery, with failing to supervise so as to prevent violations by Hoffman. The charges against Hoffman included improper switching (inducing a customer to sell one fund and buy another solely to receive a commission), not informing customers of sales charges, and making unsuitable recommendations. The law judge found that Hoffman fully informed the customers about their alternatives and about the costs and risks of investments they purchased. The law judge concluded that there were no improper mutual fund switches or other illegal sales practices, and dismissed the charges against Hoffman.

Montgomery was the Chief Compliance Officer at FSC Securities, the broker-dealer with which Hoffman was associated. Since Hoffman did not violate the antifraud provisions, the failure to supervise charge failed. Additionally, the law judge concluded that Montgomery was not Hoffman's supervisor; moreover, Montgomery did everything within his power to maintain and improve supervision and compliance with the securities laws at the broker-dealer. ## SEC BARS FORMER MONEY MANAGER S. JAY GOLDINGER

On January 27, the Commission issued an order barring S. Jay Goldinger, once a well-known Beverly Hills-based money manager, from association with any broker or dealer. Goldinger consented to the Commission's order based on the entry of a final judgment by Judge Christina A. Snyder of the U.S. District Court for the Central District of California, on January 3, 2000. The final judgment enjoins Goldinger from any future violations of the antifraud, periodic reporting, books and records, and internal control provisions of the federal securities laws. The judgment also orders Goldinger to pay back his ill-gotten gains (plus prejudgment interest thereon) and civil money penalties in amounts to be determined later.

The Commission's complaint, filed on November 8, 1999, alleged that Goldinger stole \$15.9 million from the Tustin, California-based public company PairGain Technologies, Inc. as part of a Ponzi-like scam whereby he commingled the funds of PairGain and his other clients, then engaged in a massive securities-futures trading misallocation scheme. Through the scheme, which occurred during 1994 and 1995, Goldinger shifted tens of millions of dollars from some clients, including PairGain, to other clients, simultaneously generating enormous income for himself. Goldinger's scheme eventually collapsed when he began to suffer overall trading losses, leaving PairGain and others with tens of millions of dollars in losses. By engaging in the above conduct, Goldinger violated, and aided and abetted violations, of Section 17(a) of the Securities Act of 1933 and Sections 10(b), 13(a), 13(b)(2)(A), 13(b)(5), and 15(c)(1)(A) of the Securities Exchange Act of 1934 and Rules 10b-5, 12b-20, 13a-13, and 13b2-1 thereunder (SEC v. S. Jay Goldinger, Civil Action No. 99-11539, LGB, CTx, C.D. Cal., judgment entered January 3, 2000). (Rel. 34-42358; File No. 3-10135)

## CIVIL CONTEMPT ACTION FILED AGAINST JOHN WAYNE ZIDAR AND FIVE OTHERS

The Central Regional Office announced the filing of a civil contempt action on January 24, 2000, against John Wayne Zidar of Gilbert, Arizona, John Wesley Matthews of Chandler, Arizona, James Eman Ringquist d/b/a Times Two Design of Grand Marais, Minnesota, Clyde Bob Dark of Fruit Heights, Utah, Susan V. Fitzgerald of Enumclaw, Washington, and Beth Durtschi Moore of Orange, Texas. This action is based on their failure to comply with orders issued by the United States District Court for the District of Colorado on December 23, 1999, by which they were required to produce documents and testify in response to Commission subpoenas issued in the investigation captioned Oakleaf International. The Commission's contempt action and the subpoena enforcement action that preceded it allege that Oakleaf International, which characterizes itself as a "worldwide" asset enhancement fund, " may be defrauding investors by claiming a track record of 120% annual returns to be generated through an undefined investment scheme. The contempt action further alleges that Oakleaf International has raised over \$20 million from investors. The contempt action also seeks fines and attorneys fees.

An order has been issued on an application filed by Manufacturers Investment Trust and Manufacturers Securities Services, LLC under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act and Rule 18f-2 under the Act. The order permits applicants to enter into and materially amend investment management agreements with subadvisers without shareholder approval. (Rel. IC-24261 - January 27)

## NEW COVENANT FUNDS AND NEW COVENANT TRUST COMPANY, N.A.

An order has been issued on an application filed by New Covenant Funds and New Covenant Trust Company, N.A. exempting applicants from Section 15(a) of the Investment Company Act and Rule 18f-2 under the Act. The order permits applicants to enter into and materially amend subadvisory agreements without obtaining shareholder approval. (Rel. IC-24262 - January 27)

# STANDISH, AYER & WOOD INVESTMENT TRUST, ET AL.

An order has been issued on an application filed by Standish, Ayer & Wood Investment Trust, et al. for an exemption from Section 17(a) of the Investment Company Act. The order permits certain limited partnerships to transfer all their assets to corresponding new series of a registered open-end management investment company in exchange for shares of the new series. (Rel. IC-24263 - January 27)

## GOLDEN AMERICAN LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 26(b) of the Investment Company Act to Golden American Life Insurance Company, Golden American Life Insurance Company Separate Account A, Golden American Life Insurance Company Separate Account B, Equitable Life Insurance Company of Iowa, Equitable Life Insurance Company of Iowa Separate Account A, First Golden American Life Insurance Company of New York, and First Golden American Life Insurance Company of New York Separate Account NY-B approving the substitution of shares of the Mid-Cap Growth Series of The GCG Trust for shares of the Growth Opportunities Series of The GCG Trust.
