RULES AND RELATED MATTERS

NEW RULE AND RULE AMENDMENTS CONCERNING INVESTMENT COMPANY FOREIGN CUSTODY ARRANGEMENTS

The Commission has issued a release that adopts a new Rule 17f-7 under the Investment Company Act and amendments to Rule 17f-5 concerning the foreign custody of investment company assets. The new rule and amendments are designed to provide a workable framework under which an investment company can protect its assets while maintaining them with a foreign securities depository. In the same release, the Commission is extending the compliance date for previous amendments to Rule 17f-5 (adopted in Rel IC-22658 (May 12, 1997)), which the new rule and amendments will supersede FOR FURTHER INFORMATION, CONTACT: Jaea F. The Commission approved a proposed rule change submitted by the <u>Pacific Exchange</u> (SR-PCX-99-37) to authorize the PCX ITS Coordinator to accept inbound commitments on behalf of other PCX specialists. (Rel. 34-42708)

The Commission approved a proposed rule change submitted by the <u>MBS Clearing</u> <u>Corporation</u> (SR-MBSCC-99-8) that will amend MBSCC's rules to clarify MBSCC's procedures when there is a disruption in the Electronic Pool Notification (EPN) service. The proposed rule change will also allow MBSCC members to terminate their EPN usage by providing MBSCC with written notice ten days prior to termination instead of thirty days prior to termination (Rel. 34-42721)
