RULES AND RELATED MATTERS

PROPOSED AMENDMENTS TO NATIONAL MARKET SYSTEM PLAN

The Commission is proposing amendments to the Options Price Reporting Authority (OPRA) Plan for Reporting of Consolidated Options Last Sale Reports and Quotation Information (OPRA Plan). The proposed amendments set forth two alternatives to establish a formula to allocate the message capacity of the OPRA system among the participant exchanges. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 8. (Rel. 34-42755)

ENFORCEMENT PROCEEDINGS

SEC SUES INTERNET HUCKSTER FOR FRAUDULENT STOCK TOUTING

The Commission today announced that it filed suit against Mark Malatesta, individually and doing business as Financial Solutions Web, in the Central District of California. The SEC's complaint alleges that the defendant engaged in an Internet scheme in which he fraudulently touted the stock of two issuers.

The Commission's complaint alleges Malatesta operated a web site called Financial Solutions Web (FSW). Through this site, Malatesta recommended that the public purchase stock in two companies traded on the NASD OTC Bulletin Board. The complaint alleges that Malatesta made fraudulent statements about his and FSW's background, including the false claims that FSW's investment clients included the California State Teachers Retirement System and California Public Employee Retirement System retirement funds and that Malatesta was managing over \$35 million dollars in client investments. Beyond misrepresenting his background and credentials, Malatesta failed to disclose that he was paid to tout the stock of the two issuers and, in fact, falsely denied that he was being paid to make glowing comments about the stocks. Malatesta also used the alias SafeCents to tout the stocks on the Raging Bull and Silicon Investor bulletin boards. In response to inquiries by others on the bulletin boards, Malatesta misrepresented the nature of his compensation agreements with the two issuers.

As a result of his alleged misconduct, the complaint charges the defendant with violating Sections 17(a) and (b) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and the Commission's Rule 10b-5. The complaint seeks permanent injunctive relief against the defendant and civil monetary penalties. [SEC V. SEC V. BENJAMIN FRANKLIN COOK, ET AL.

On May 1, Judge Jerry Buchmeyer of the U.S District Court for the Northern District of Texas, Dallas Division, found C. Kelly Olsen in contempt of Court and issued a bench warrant for his arrest, fined him \$50,000 and struck all pleadings filed by him denying the Commission's allegations Olsen, a resident of Temecula, California, is expected to be detained by U.S. Marshals and transported to Dallas where he will be incarcerated.

On March 16, 1999, the Commission brought an action alleging that Dennel Finance Limited, Benjamin Franklin Cook and others engaged in a fraudulent scheme to offer and sell unregistered "prime bank" securities throughout the United States. The complaint further alleged that the defendants, who targeted religious groups and persons investing retirement funds, cheated more than 100 investors nationwide of \$30 million in non-existent "prime bank" note programs. On April 2,1999, the Court entered a Preliminary Injunction and appointed a Temporary Receiver to take control of the defendant's assets for the benefit of investors.

Olsen was named as a relief defendant in the Dennel action and had been required to provide an accounting and to turn over certain assets to the Temporary Receiver Because of Olsen's failure to account for certain real and personal property and his transfer of approximately \$500,000, both in violation of the Preliminary Injunction, Judge Buchmeyer held Olsen in contempt of Court Olsen will join Mr. Cook who was previously incarcerated for contempt. INSIDER TRADING CHARGES FILED AGAINST AMERICAN HOMEPATIENT DIRECTOR. HENRY BLACKSTOCK

The Commission announced the filing of a complaint for insider trading in the securities of American HomePatient, Inc. against Henry T. Blackstock, who lives in a suburb of Birmingham, Alabama. American HomePatient is a health care company headquartered in Brentwood, Tennessee. Blackstock has been a member of the board of directors of American HomePatient for seventeen years and a member of the audit committee for eleven At the time of the conduct alleged in the complaint, Blackstock resided in Ponte Vedra Beach, Florida.

The complaint, filed in the U.S. District Court in Jacksonville, Florida, alleges that during September 1998, Blackstock learned material, nonpublic information about certain

accounting charges that American HomePatient planned to establish that would take the company from a profit to a loss. Prior to any public announcement regarding the accounting charges. Blackstock sold 4,000 shares of American HomePatient stock held in a friend's account over which Blackstock had trading authority, at prices ranging from \$7.00 to \$8.75 per share. On September 30, 1998, after American HomePatient issued a press release announcing that its annual financial results would be significantly lower than expected. and that it planned to establish a significant accounting charge, the price of American HomePatient stock dropped to less than \$2.00 per share. By selling the American HomePatient stock prior to the public announcement. Blackstock caused his friend to avoid losses of approximately \$25,000.

The complaint filed against Blackstock seeks disgorgement, prejudgment interest and a civil monetary penalty from Blackstock, as well as an injunction against him for future violations of Section 17(a) of Securities Act and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Commission acknowledges the assistance provided by NASD Regulation, Inc. [Securities and Exchange Commission v Henry T. Blackstock, U.S D.C. for the Middle District of Florida, Civil Action No. 3 00CV472-J21C] (LR-16539)

INVESTMENT COMPANY ACT RELEASES

NEW YORK LIFE INSURANCE AND ANNUITY CORPORATION. ET AL

A notice has been issued giving interested persons until May 26, to request a hearing on an application filed by New York Life Insurance and Annuity Corporation (NYLIAC) and NYLIAC Variable Annuity Separate Account - III (SA III), any other separate accounts of NYLIAC (Future Accounts) that support in the future variable annuity policies and certificates that are substantially similar in all material respects to the SA III policies, and NYLife Distributors, Inc. (NYLIFE Distributors) (collectively referred to herein as Applicants) Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder, to permit the recapture of credits applied to premium payments made under certain deferred variable annuity policies and certificates that NYLIAC will issue through SA III (the policies and certificates are referred to as "Mainstay Policies" or "LifeStages Policies," collectively, the SA III Policies). Applicants also request that the order extend to the recapture of credits applied to policies and certificates that NYLIAC may issue in the future through SA III or any Future Account which policies and certificates are

substantially similar to the SA III Policies in all material respects (Future Policies). Applicants further request that the order extend to any National Association of Securities Dealers, Inc. member broker-dealer controlling or controlled by, or under common control with NYLIAC, whether existing or created in the future, that serves as a distributor or principal underwriter of the SA III Policies and Future Policies. WARBURG, PINCUS BALANCED FUND, INC. ET AL.

A notice has been issued giving interested persons until May 25 to request a hearing on an application filed by Warburg, Pincus Balanced Fund et al., for an order under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain joint transactions. The order would permit certain registered management investment companies to deposit their uninvested cash balances in one or more joint accounts to be used to enter into repurchase agreements. (Rel. management services for transactions involving European sovereign debt instruments. Publication of the proposal is expected in the Federal Register during the week of May 8, 2000. (Rel. 34-42729)
