# **ENFORCEMENT PROCEEDINGS**

# ENFORCEMENT ACTIONS AGAINST FORMER EXECUTIVES AND DIRECTORS OF THE CRONOS GROUP

The Commission announced the filing of a civil injunctive action against Stefan M. Palatin, the former chairman and CEO of The Cronos Group, a Luxembourg holding company that manages and owns marine cargo containers. The Commission alleges that Palatin caused Cronos to misrepresent or fail to disclose a series of transactions by which Palatin obtained more than \$10 million from Cronos or from a customer of the company who owed the funds to Cronos. The Commission alleges that as a consequence of Palatin's misconduct the company misrepresented or failed to disclose the transactions in the company's registration statement, public statements to shareholders, and in filings with the Commission between 1995 and 1998. The Commission also alleges that Palatin, through another entity that he controlled, sold shares in Cronos' IPO without disclosure. The Commission further alleges that Palatin pledged collateral he did not own to secure a loan from the company and he caused the company to make misrepresentations concerning the collateral.

The Commission seeks an order permanently enjoining Palatin from violating the antifraud, reporting, books and records, and other provisions of the federal securities laws including Section 17(a) of the Securities Act of 1933, Sections 10(b), 13(a), 13(b)(2)(A), 13(b)(2)(B), and 13(b)(5) of the Securities Exchange Act of 1934, and Rules 10b-5, 12b-20, 13a-1, 13a-16, 13b2-1, 13b2-2 thereunder, and permanently barring Palatin as an officer or director of a public company.

Separately, the Commission instituted an administrative cease and desist proceeding against Axel E. Friedberg, a former director, and Rudolf J. Weissenberger, a former director, chairman and CEO of Cronos. The Commission found that Friedberg had caused violations of the antifraud and reporting provisions of the federal securities laws. Without admitting or denying the Commission's findings, Friedberg consented to an order compelling him to cease and desist from causing violations, or any future violations, of the antifraud and reporting provisions of the federal securities laws.

The Commission also found that Weissenberger was a cause of Cronos' violations of the reporting provisions of the federal securities laws. Without admitting or denying the Commission's findings, Weissenberger consented to an order compelling him to cease and desist from causing violations, or any future violations, of the reporting provisions of the federal securities laws.
