ENFORCEMENT PROCEEDINGS

COURT ORDERS INJUNCTIONS, FINE AND DISGORGEMENT AGAINST JEREMIAH AND MICHAEL HEGARTY FOR DEFRAUDING CLIENTS

On August 22, the United States District Court for the District of Massachusetts entered a final judgment against Jeremiah J. Hegarty and Michael P. Hegarty of Osterville and North Easton, Massachusetts, respectively, for violations of the antifraud and other provisions of the federal securities laws. The court permanently enjoined J. Hegarty and M. Hegarty from future violations of several antifraud provisions of the federal securities laws and imposed a civil penalty of \$125,000 against J. Hegarty. The Court ordered M. Hegarty to disgorge \$92,998, which represents the amount of commissions he received from customer transactions in the fall of 1992.

J. Hegarty was principal of Hyannis Trading Advisors, Inc., a registered investment adviser. He specialized in trading index options. M. Hegarty, a registered representative at a brokerage firm, assisted his brother by soliciting clients, entering trades in the clients' accounts, and serving as the primary client contact. At the height of Hyannis Trading's activity in 1992, it had about \$6.5 million under management and over one hundred clients. In the fall of 1992, Hyannis Trading lost almost all of this money, leaving many clients in deficit positions.

The Court found that the Hegartys defrauded Hyannis Trading's clients by failing to disclose that they lost the ability to monitor account balances in the fall of 1992, which handicapped their ability to employ risk limiting techniques. The Court also found that the brothers failed to disclose that they changed trading strategies in the fall of 1992 by abandoning the risk limiting techniques originally described to clients. The Court also found that J. Hegarty made unsuitable trades and that Hyannis Trading's marketing brochure misled investors about past returns. Finally, the Court found that Hyannis Trading violated the securities laws by collecting illegal performance fees and that J. Hegarty aided and abetted that violation. The Court dismissed the charges against Hyannis Trading prior to trial, because the company was dissolved. [SEC v. Jeremiah J. Hegarty and Michael Hegarty, Civ. Action. No. 96-12367-RCL, D. FINAL JUDGMENTS OF PERMANENT INJUNCTION ENTERED AGAINST EQUITYALERT.COM, INC., AND HARMEL RAYAT

The Commission announced that on August 8 the Honorable Roslyn Silver, U.S. District Judge, District of Arizona, issued permanent injunctions against EquityAlert.Com, Inc., and Harmel S. Rayat. The defendants, who consented without admitting or denying the Commission's allegations, were enjoined from violating the anti-touting provisions of the Securities Act of 1933. Each defendant was ordered to pay a civil penalty of \$20,000.

The Commission alleged that the defendants had violated Section 17(b) of the Securities Act of 1933 by failing to disclose the compensation they had received from approximately 18 issuers whose stocks they had promoted on their website and in more than one million daily e-mail messages disseminated worldwide. It was also alleged that the defendants disseminated daily press releases that compiled and referred to the promotional statements, claiming EquityAlert had provided its subscribers with "proprietary coverage" of these "top momentum" issuers. NATIONWIDE SEPARATE ACCOUNT TRUST, ET AL.

A notice has been issued giving interested persons until September 18, 2000, to request a hearing on an application filed by Nationwide Separate Account Trust (NSAT) and Villanova Mutual Fund Capital Trust (VMF) (collectively the Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder, to the extent necessary to permit shares of any current or future series of NSAT designed to fund insurance products and shares of any other investment company or series thereof now or in the future registered under the Act that is designed to fund insurance products and for which VMF or any of its affiliates, may serve in the future, as investment adviser, administrator, manager, principal underwriter, or sponsor to be offered and sold to, and held by (1) variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies, and (2) qualified pension and retirement plans outside of the separate account context. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-00-31) relating to the application of independent director and audit committee listing requirements to limited partnerships. EXTENSION OF COMMENT PERIOD

The National Association of Securities Dealers, through its wholly owned subsidiary the Nasdaq Stock Market, Inc., filed a proposal to establish the Nasdaq Order Display Facility and modify the Nasdaq Trading Platform (SuperMontage). Amendments Nos. 5, 6, and 7 were published for comment in the Federal Register. The original comment period expires on August 30, 2000. To give the public additional time to comment on the NASD's SuperMontage proposal, the comment period is extended to September 14, 2000. Publication of this extension is expected in the Federal Register during the week of August 28. (Rel. 34-43202)
