FEE RATE ADVISORY #5

Congress passed an extension, through October 25, 2000, of the current continuing resolution. It was signed by the President on October 20, 2000. Therefore the fee rate on filings made pursuant to Section 6(b) of the Securities Act of 1933 will remain at the current rate of \$264 per \$1,000,000. Please note that when an appropriations bill is enacted, the fee rate will decrease to \$250 per \$1,000,000.

ENFORCEMENT PROCEEDINGS

COMMISSION SETTLES ACTION AGAINST EDWARD COX AND COX SECURITIES, INC.

The United States District Court for the Central District of California has entered Final Judgments of Permanent Injunction against defendants Edward R. Cox (Cox) and his company Cox Securities, Inc. (Cox Securities) on October 17, 2000. The Final Judgments permanently enjoin Cox and Cox Securities from future violations of the antifraud provisions of the federal securities laws. Cox was a floor broker on the Pacific Exchange where he executed securities trades for a broad institutional client base.

The complaint alleges that from at least November 1996 through March 12, 1998, Cox created over a thousand false trades in which he moved trading losses to other Exchange members. Ultimately, this scheme involved at least 31 different securities, victimized at

least 34 different broker-dealers and 19 floor specialists and resulted in over \$1.5 million in losses. The Commission charged both defendants with violating the antifraud provisions of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder. The Commission also charged Cox Securities with violating, and Cox with aiding and abetting violations of, the broker-dealer books and records requirements of Section 17(a)(1) of the Exchange Act and Rule 17a-3 thereunder.

Both defendants, without admitting or denying the allegations in the complaint, consented to the entry of judgments enjoining them from future violations of Section 17(a) of the Securities Act of 1933 and Sections 10(b) and 17(a)(1) of the Exchange Act and Rules 10b-5 and 17a-3 thereunder and not assessing civil penalties based upon Cox and Cox Securities' demonstrated inability to pay. In addition, the Commission settled an administrative proceeding based upon the entry of the injunction, whereby Cox and Cox Securities, without admitting or denying the Commission's findings, consented to an Order barring Cox from association with any broker or dealer and revoking Cox Securities' registration as a broker-dealer.

HOLDING COMPANY ACT RELEASES

EXELON CORPORATION

The Commission has issued an order approving an application-declaration filed under Sections 3(a)(1), 4, 5, 6(a), 7, 8, 9(a)(1), 9(a)(2), 9(c)(3), 10, 11(b), 12 and 13 of the Act and Rules 43, 44, 54 and 80 through 92 by Exelon Corporation (Exelon), a company not currently subject to the Act, in connection with the proposed acquisition of PECO Energy Company (PECO), a Pennsylvania electric and gas public-utility company and a public-utility holding company exempt from registration under Section 3(a)(1) of the Act by Rule 2, and Unicom Corporation (Unicom), an Illinois public-utility holding company exempt from registration by order under Section 3(a)(1) of the Act. Through the acquisition and related transactions, Exelon would acquire three wholly owned publicutility subsidiaries of PECO that own and operate a hydroelectric generating facility; Unicom's principal subsidiary, Commonwealth Edison Company (ComEd), an electric public-utility company and a holding company exempt from registration by order under Section 3(a)(1); and Exelon Generation Company, LLC, a subsidiary to which the generating assets of ComEd and PECO will be transferred following the acquisition. Following the acquisition, Exelon will register under Section 5 of the Act. The order also approves a system service company and intrasystem transactions. The order reserves jurisdiction over the retention of certain nonutility interests of Unicom and PECO. (Rel. 35-27256)
