COMMISSION ANNOUNCEMENTS

FEE RATE ADVISORY #6

On October 25, Congress passed and the President signed a one-day extension, through October 26, 2000, of the current continuing resolution. Therefore the fee rate on filings made pursuant to Section 6(b) of the Securities Act of 1933 will remain at the current rate of \$264 per \$1,000,000. Please note that when an appropriations bill is enacted, the fee rate will decrease to \$250 per \$1,000,000.

We will issue further notices as appropriate to keep filers and registrants informed of developments affecting the Section 6(b) fee rate. This information will be posted at the SEC's Internet website at http://www.sec.gov.

ENFORCEMENT PROCEEDINGS

COMMISSION SUSTAINS NASD DISCIPLINE OF EAST/WEST SECURITIES COMPANY AND LESLIE HARRIS

The Commission has sustained the NASD's findings that East/West Securities Company failed to conduct a training needs analysis or to establish a "Firm Element" continuing education program. The NASD also found that the firm did not have adequate supervisory procedures to monitor compliance with the NASD's training requirements. It censured applicants and fined them \$5,000, jointly and severally.

The NASD requires each member to conduct an annual training-needs analysis. Based on this analysis, the member is to implement a "Firm Element" training program to educate its employees on job- and product-related issues that are specific to the member. Each member is also required to conduct a "Regulatory Element" training program,

which is administered by the NASD and provides periodic trading in broadly applicable regulatory matters. East/West submitted a copy of the NASD's Regulatory Element outline as its "Firm Element" training program. The Commission determined that the NASD had provided adequate guidance to members about these requirements. The Commission further determined that the firm's supervisory procedures were not adequate and that Harris had been responsible for the firm's compliance with these requirements. INVESTMENT COMPANY ACT RELEASES

THE WACHOVIA VARIABLE INSURANCE FUNDS, ET AL.

A notice has been issued giving interested persons until November 14, 2000, to request a hearing on an application filed by The Wachovia Variable Insurance Funds (Trust) and Wachovia Asset Management (Wachovia), a business unit of Wachovia Bank, N.A., seeking an order to permit shares of the Trust and shares of any other investment company or series thereof that is designed to fund insurance products and for which Wachovia, or any of its affiliates, may serve in the future as investment adviser, administrator, manager, principal underwriter or sponsor (Future Trusts, together with Trust, Trusts) to be sold to and held by (a) variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies, (b) qualified pension and retirement plans outside of the separate account context, and (c) separate accounts that are not registered under the Act pursuant to exemptions from registration under Section 3(c) of the Act.
