ENFORCEMENT PROCEEDINGS

THE COMMISSION INSTITUTES CEASE AND DESIST PROCEEDINGS AND PROCEEDINGS UNDER RULE 102(e) AGAINST PAT ROSSETTI AND JEFFREY YONKERS

On October 31, 2000, the Commission instituted administrative and cease and desist proceedings pursuant to Section 21C of the Securities Exchange Act of 1934 and Rule

102(e) of the Commission's Rules of Practice against Pat A. Rossetti (Rossetti) and Jeffrey M. Yonkers (Yonkers).

The Order Instituting Proceedings alleges that Pat A. Rossetti and Jeffrey M. Yonkers, while employed as CPAs with the firm of Marcum & Kliegman, LLC in Woodbury, New York, violated Section 10A of the Exchange Act; willfully aided and abetted violations of Section 13(a) of the Exchange Act and Rules 13a-1 and 13a-13 thereunder by the firm's client, Detour Magazine, Inc.; and engaged in improper professional conduct.

It is alleged that Rossetti and Yonkers learned that Detour's quarterly financial statements were being prepared using completely fictional numbers, rather than numbers that reflected the company's actual results of operations. The company's chief financial officer was allegedly using simple fractions of numbers from existing financial statements in the quarterly financial statements Detour filed with the Commission on Forms 10-QSB. It is further alleged that Rossetti and Yonkers did nothing upon learning of the false financial statements, even though the law required them to notify the company's management, board of directors or the Commission of the illegal act. Detour's quarterly financial statements were allegedly prepared using fractions throughout 1997 and 1998.

It is also alleged that Rossetti and Yonkers violated the securities laws by failing to properly record, or require Detour to record, an expense related to certain options Detour issued to consultants in 1997. In addition, it is alleged that, because the options were issued at a price far below the stock's fair value at the time, Rossetti and Yonkers should have recorded a material expense item in connection with the transaction. The failure to do so allegedly caused the financial statements of Detour, as contained in its filings with the Commission during 1997 and 1998, to materially misrepresent the company's financial condition and results of operations.

A public hearing will be scheduled to determine whether the allegations against Rossetti and Yonkers are true and, if so, what sanctions, if any, are appropriate in the public interest. (Rels. 34-43497; AAE Rel. 1338; File No. 3-10354)

PROCEEDINGS UNDER RULE 102(e) INSTITUTED AGAINST EDWARD HORTON AND HORTON & COMPANY

On October 31, the Commission instituted proceedings under Rule 102(e) of its Rules of Practice against Horton & Company of Wayne, New Jersey and its managing partner, Edward C. Horton.

It is alleged that Horton & Company and Horton violated the securities laws in connection with the firm's work as auditor for Monarch Investment Properties, Inc., a microcap issuer. Specifically, the firm failed to properly record, or require Monarch to record, an expense related to certain options Monarch issued to consultants in 1997. It is also alleged that, because the options were issued at a price far below the stock's fair value at the time, Horton and the audit firm should have recorded a material expense item in connection

with the transaction. The failure to do so allegedly caused the financial statements of Monarch, as contained in its filings with the Commission during 1997 and 1998, to materially misrepresent the company's financial condition and results of operations.

It is further alleged that Horton and Horton & Company audited their own work with respect to Monarch, and therefore lacked independence. Horton & Company's staff accountant allegedly made all the bookkeeping entries for Monarch during the time Monarch was a client of the audit firm, using raw data such as check stubs and bank statements. Horton & Company thereafter audited the resulting financial statements.

In addition, it is alleged that both Horton & Company and Horton willfully aided and abetted violations of Section 13(a) of the Securities Exchange Act and Rules 13a-1 and 13a-13 thereunder, and also engaged in improper professional conduct.

A public hearing will be scheduled to determine whether the allegations against Horton and Horton & Company are true and, if so, what sanctions, if any, are appropriate in the public interest. (Rel. 34-43498; AAE Rel. 1339; File No. 3-10355)

SEC SUES SOLUCORP INDUSTRIES LTD.'S AUDITOR IN PENDING CIVIL ACTION FOR VIOLATING SECTION 10A

On October 31, 2000, the Commission filed an amended complaint in a pending civil injunctive action in the United States District Court for the Southern District of New York. The initial complaint, filed on December 13, 1999, alleged, among other things, that Solucorp Industries Ltd. had improperly recognized \$500,000 in contingent licensing fees, 40% of revenues, during the quarter ended September 30, 1997. The complaint further alleged that management had backdated a licensing agreement to September 15, 1997 in order to cover-up its improper revenue recognition. The amended complaint adds a claim against Solucorp's auditor, Glenn R. Ohlhauser of the Canadian auditing firm MacKay & Partners, alleging that he violated Section 10A of the Securities Exchange Act of 1934. The amended complaint alleges that Ohlhauser failed to take appropriate action on discovering that Solucorp may have backdated the licensing agreement. Specifically, Ohlhauser failed to (1) determine whether it was likely that Solucorp committed an illegal act by backdating the agreement; (2) determine the possible effect of the illegal act on Solucorp's financial statements for the six-month transition period ended December 31, 1997, including the contingent monetary effect of penalties, fines and damages; and (3) inform the appropriate level of Solucorp's management and assure that Solucorp's audit committee was adequately informed about the illegal act. Ohlhauser made this discovery during his audit of Solucorp's December 31, 1997 financial statements.

This is the first civil injunctive action brought against an auditor for violating Section 10A. [SEC v. Solucorp Industries Ltd., et al., 99 Civ. 11965, WCC, SDNY] LR-16785; AAE Rel. 1337)

AGAINST AND **ORDERS** DEFAULT COURT ENTERS JUDGMENT BY DISGORGEMENT BY YES ENTERTAINMENT DEFENDANTS

United States District Court Judge Christina A. Snyder, Central District of California, entered Judgment by Default against Yes Entertainment, LLC, Yes Entertainment Network, LLC, Yes Entertainment Network, Inc., Ronald T. Mulhall and Eugene M. Carriere for violating the antifraud provisions of the federal securities laws and for selling unregistered securities. The Court ordered these Defendants to disgorge more than \$14 million in ill-gotten gains and imposed separate civil money penalties against Mulhall and Carriere.

The Court ordered the Defendants to pay disgorgement in the amount of \$13,794,265 and prejudgment interest in the amount of \$752,543, a total of \$14,546,808. Defendants are jointly and severally liable for this amount. In addition, the Court ordered Mulhall and Carriere each to pay a civil money penalty of \$110,000 for their respective roles in Defendants' fraudulent scheme.

The Commission filed an emergency action against the Defendants one year ago in the United States District Court for the Central District of California, charging Defendants with violating Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. At that time,. the Court issued a temporary restraining order and imposed an asset freeze. Commission charged the Defendants with misrepresenting or omitting material facts concerning the amount of commissions being paid to sales agents, the use of investor proceeds, and Mulhall's professional accomplishments. INVESTMENT COMPANY ACT RELEASES

AIG LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until November 21, 2000, to request a hearing on an application filed by AIG Life Insurance Company (AIG), Variable Account I. American International Life Assurance Company of New York (AIL), and AIG Equity Sales (collectively, Applicants). Applicants seek an order of exemption pursuant to Section 6(c) of the Investment Company Act to the extent necessary to permit the recapture, under specified circumstances, of credits applied to premium payments made under the flexible premium deferred variable annuity contract that AIG will issue through Variable Account I (the Contract), as well as other contracts that AIG or AIL may issue in the future through their existing or future separate accounts that are substantially similar in all material respects to the Contract (Future Contracts). Applicants also request that the order being sought extend to any other National Association of Securities Dealers, Inc. member broker-dealer controlling or controlled by, or under common control with, AIG, whether existing or created in the future, that

HOLDING COMPANY ACT RELEASES

NISOURCE INC.

The Commission has issued an order approving an application-declaration by NiSource Inc. (NiSource), an Indiana holding company exempt from registration by order under Section 3(a)(1) of the Act, and its wholly owned subsidiary, New NiSource Inc. (New NiSource, and, together with NiSource, Applicants), in connection with a proposed acquisition of Columbia Energy Group, Inc. (Columbia), a Delaware registered holding company. Following the acquisition, New NiSource, which will change its name to NiSource Inc., will serve as a holding company for Columbia and its subsidiaries and the current subsidiaries of NiSource. New NiSource will register as a holding company under Section 5 of the Act. Columbia will remain a registered holding company. The order authorizes NiSource to incur up to \$6 billion of additional short-term debt under a credit facility in connection with the acquisition. The order also approves interim service arrangements following the acquisition. Further, the order requires the disposition of the water properties of NiSource and reserves jurisdiction over the retention of certain other nonutility properties. (Rel. 35-27263)
