## **INVESTMENT COMPANY ACT RELEASES**

#### **MUTUAL OF AMERICA INVESTMENT CORPORATION, ET AL.**

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Mutual of America Investment Corporation (Investment Company) and Mutual of America Capital Management Corporation (Capital Management) from Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-3(T)(b)(15), thereunder, to permit shares of the Investment Company and shares of any other investment company or portfolio that is designed to fund variable life insurance policies and/or variable annuity contracts (collectively, Variable Contracts) and for which Capital Management or its affiliates may serve in the future as investment adviser, manager, principal underwriter, sponsor, or administrator to be sold to and held by (i) separate accounts funding Variable Contracts issued by both affiliated and unaffiliated life insurance companies and (ii) qualified pension and retirement plans outside the separate account context. (Rel. IC-24732 – November 8)

#### **NEW ENGLAND LIFE INSURANCE COMPANY, ET AL.**

A notice has been issued giving interested persons until November 30 to request a hearing on an application filed by New England Life Insurance Company (NELICO), New England Variable Annuity Separate Account, New England Variable Life Separate Account, The New England Variable Account (the three accounts collectively, the Separate Accounts), Metropolitan Life Insurance Company (MetLife), the Metropolitan Series Fund, Inc. (Metropolitan Series), and the New England Zenith Fund (the Zenith Fund). (NELICO, MetLife, and the Separate Accounts are collectively referred to as the Section 26 Applicants. The Section 26 Applicants, the Metropolitan Series, and the Zenith Fund are collectively referred to as the Section 17(b) Applicants.) The Section 26 Applicants request an order pursuant to Section 26(b) of the Investment Company Act to permit certain registered unit investment trusts to substitute shares of the Putnam International Stock Portfolio of the Metropolitan Series for shares of the Morgan Stanley International Magnum Equity Series of the Zenith Fund currently held by those unit investment trusts. The Section 17(b) Applicants request an order pursuant to Section 17(b) of the Act to permit certain in-kind redemptions of portfolio securities in connection with the substitution. (Rel. ## SUMMIT MUTUAL FUNDS, INC.

A notice has been issued giving interested persons until December 1, 2000, to request a hearing on an application filed by Summit Mutual Funds, Inc. (the Fund) and Summit Investment Partners, Inc. (the Adviser) (collectively the Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act exempting them and certain life insurance companies and their separate accounts from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder (including any comparable provisions of a permanent rule that replaces Rule 6e-3(T) or Rule 6e-2, as subsequently amended) to the extent necessary to permit series of shares of any current or future investment portfolio of the Fund to be sold to and held by (a) variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies, and (b) qualified pension and retirement plans, including, without limitation, those trusts, plans accounts, contracts or annuities described in Sections 401(a), 403(a), 403(b), 408(a), 408(b), 414(d), 457(b), 408(k), or 501(c)(18) of the Internal Revenue Code of 1986, as amended, and any other trust, plan, account, contract or annuity that is determined to be within the scope of Treasury Regulation 1.817.5(f)(3)(iii) outside of the separate account context. ## **PROVIDENT INSTITUTIONAL FUNDS, ET AL.**

An order has been issued under the Investment Company Act exempting Provident Institutional Funds, et al. from the provisions of Section 17(a) of the Act. The order would permit a registered open-end management investment company to enter into repurchase agreements with an affiliated person. (Rel. IC-24735 – November 9)

## HOLDING COMPANY ACT RELEASES

## **KEYSPAN CORPORATION, ET AL.**

An order has been issued authorizing KeySpan Corporation (KeySpan), a New York public utility holding company currently claiming exemption from registration under Section 3(a)(1) of the Act by Rule 2, to acquire all of the outstanding common shares of Eastern Enterprises, a Massachusetts public utility holding company also claiming exemption from registration under Section 3(a)(1) of the Act by Rule 2. After completion of the acquisition, KeySpan will register as a holding company under Section 5 of the Act. (Rel. 35-27271)

## **KEYSPAN CORPORATION, ET AL.**

An order has been issued authorizing KeySpan Corporation, a New York public utility holding company presently claiming exemption from registration under the Act by Rule 2, and its subsidiaries; Eastern Enterprises, a Massachusetts public utility holding company also presently claiming exemption from registration under the Act by Rule 2, and its subsidiaries; and EnergyNorth, Inc., a New Hampshire public utility holding company also presently claiming exemption from registration under the Act by Rule 2, and its subsidiaries, to engage in various financing transactions and intrasystem transactions following the consummation of their proposed merger and registration under the Act. ## THE SOUTHERN COMPANY, ET AL.

An order has been issued authorizing the Southern Company (Southern), a registered holding company, to organize and acquire all of the outstanding capital stock of a special purpose financing vehicle (SPV), and the SPV to issue commercial paper for the benefit of Southern's subsidiary companies. In addition, the order authorizes Georgia Power Company (Georgia), Gulf Power Company, Mississippi Power Company, and Savannah Electric and Power Company to borrow the proceeds from the sales of commercial paper issued for its benefit. The order also authorizes Georgia to guarantee borrowings from the SPV by Southern Electric Generating Company, which is a wholly owned public utility subsidiary of Alabama Power Company, another public utility subsidiary of Southern, and Georgia. ## ENTERGY CORP.

An order has been issued authorizing Entergy Corporation (Entergy), a registered holding company, to solicit proxies from its shareholders regarding transactions related to the merger of Entergy with FPL Group, a public utility holding company claiming exemption from the Public Utility Holding Company Act under Section 3(a)(1) of the Act. (Rel. 35-27274)

## SELF-REGULATORY ORGANIZATIONS

# **APPROVAL OF PROPOSED RULE CHANGE**

The Commission approved a proposed rule change filed by the <u>MBS</u> Clearing <u>Corporation</u> (SR-MBSCC-00-01) under Section 19(b)(2) of the Securities Exchange Act of 1934. The rule change will prohibit MBSCC from accepting a letter of credit from a participant when the participant or an affiliate of that participant issues the letter of credit. Publication of the approving release is expected in the <u>Federal Register</u> during the week of November 13. (Rel. 34-43504)

## **PROPOSED RULE CHANGES**

The <u>Chicago Board Options Exchange</u> filed a proposed rule change (SR-CBOE-00-44) relating to an interpretation of paragraph (b) of Article Fifth of its Certificate of Incorporation. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 13. (Rel. 34-43521)

The <u>Chicago Stock Exchange</u> filed a proposed rule change (SR-CHX-00-28) to amend its rule relating to the automatic execution of agency limit orders for Dual Trading System Issues. Publication of the notice in the <u>Federal Register</u> is expected during the week of November 13. (Rel. 34-43530)

## **IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE**

A proposed rule change filed by the <u>National Association of Securities Dealers</u> to amend NASD Rule 4611 relating to registration as a Nasdaq market maker in a security (SR-NASD-00-63) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 13. (Rel. 34-43533)
