COMMISSION ANNOUNCEMENTS

STATEMENT BY CHAIRMAN ARTHUR LEVITT

On December 7, Chairman Arthur Levitt made the following statement concerning an NASD Board decision:

The NASD Board's decision today to support greater disclosure of conflicts of interest by analysts who make stock recommendations in print or on television is an important and commendable step. The Commission looks forward to developing rules with the NASD and the New York Stock Exchange in short order that will establish a fair and workable disclosure regime that promotes public confidence.

Knowing whether an analyst's employer underwrote a recommended stock or whether his or her firm has a significant position in a recommended stock is important information. Investors deserve to know what possible incentives an investment services professional may have in making a particular recommendation. This can only improve the credibility of those who make recommendations to the public – credibility that has come under attack in recent months. (Press Rel. 2000-183)

ENFORCEMENT PROCEEDINGS

IN THE MATTER OF CHARLES KIRBY, ET AL.

An administrative law judge has ordered Charles F. Kirby, Gene C. Geiger, and Alfred Peeper to cease and desist from committing or causing any violations or any future violations of Sections 5(a) and 5(c) of the Securities Act of 1933. The judge rejected Respondents' arguments that they participated in offers to sell and sales of Golden Eagle, International, Inc. securities that were exempt from registration. Based on findings that Respondents violated Sections 5(a) and 5(c), Judge Murray barred Mr. Kirby and Mr. Geiger from association with a broker or dealer and from participation in a penny stock offering with the right to reapply after five years, ordered Mr. Kirby and

Mr. Geiger to disgorge \$31,352.60 and \$15,202.48, respectively, with prejudgment interest, and ordered Mr. Kirby to pay a civil penalty of \$200,000 and Mr. Geiger to pay a civil penalty of \$300,000. Judge Murray dismissed the failure to supervise charges against Edward H. Price who supervised Mr. Kirby and Mr. Geiger at Spencer Edwards, Inc. a broker-dealer in Englewood, Colorado. IN THE MATTER OF UNITED STOCK TRANSFER INC. AND JOHN DONNELL

On December 7, the Commission instituted a public administrative and cease and desist proceeding against United Stock Transfer, Inc. (United), a registered transfer agent in Englewood, Colorado, and its president, John J. Donnelly (Donnelly), a resident of Highlands Ranch, Colorado. The Division of Enforcement alleges that from November 1991 through May 2000, United repeatedly violated various rules applicable to transfer agents. The Division also alleges that, among other violations, United failed to: (i) turnaround items presented for transfer in a timely manner; (ii) maintain proper records relating to letters of appointment, routine items presented for transfer, non-routine items and turnaround time; and (iii) maintain a proper control book for each issuer and keep each issue in balance. The Division further contends that Donnelly willfully aided and abetted United in these and other violations.

The Commission instituted public administrative and cease and desist proceedings against United and Donnelly (collectively, Respondents) to determine whether: (i) the allegations against Respondents are true and to afford Respondents an opportunity to establish any defense to such allegations; (ii) any remedial action is appropriate in the public interest against Respondents pursuant to Sections 17A(c)(3) and 17A(c)(4) of the Exchange Act; (iii) pursuant to Section 21C of the Exchange Act, Respondents should be ordered to cease and desist from committing or causing any violations and any future violations of Sections 17(a)(3), 17A(d)(I) and 17(f)(2) of the Exchange Act and Rules 17Ac2-1, 17Ac2-2, 17Ad-2, 17Ad-5, 17Ad-6, 17Ad-10, 17Ad-13, 17Ad-15, 17Ad-16, 17Ad-17 and 17f-2 thereunder; and (iv) civil penalties should be ordered against Respondents pursuant to Section 21B of the Exchange Act. TELCO FINANCE N.V.

A notice has been issued giving interested persons until January 2, 2001, to request a hearing on an application filed by Telco Finance N.V. for an order under Section 6(c) of the Investment Company Act exempting applicant from all provisions of the Act. The order would permit applicant to sell certain debt securities and use the proceeds to finance the business activities of Telsim Mobile Telekomünikasyon Hizmetleri A.S. (Rel. IC-24786; International Series Rel. 1239 – December 7)

PROPOSED RULE CHANGES

The <u>American Stock Exchange</u> filed a proposed rule change (SR-Amex-00-57) to increase the maximum order size eligible for automatic execution on Auto-Ex to one hundred contracts. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 11. (Rel. 34-43660)

The Emerging Markets Clearing Corporation filed a proposed rule change (SR-EMCC-00-01) to permit EMCC to accept financial statements from an applicant prepared in accordance with International Accounting Standards or United Kingdom Generally Accepted Accounting Principles without requiring the applicant to provide a discussion of the material variations of such accounting principles from United States Generally Accepted Accounting Principles. Publication of the proposal is expected in the Federal Register during the week of December 11. (Rel. 34-43675)

The Emerging Markets Clearing Corporation filed a proposed rule change (SR-EMCC-00-04) to allow EMCC to establish membership criteria for brokers or dealers that are regulated by the Securities and Futures Authority Limited (SFA) and that act as interdealer brokers. Publication of the proposal is expected in the Federal Register during the week of December 11. (Rel. 34-43680)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES
