ENFORCEMENT PROCEEDINGS

CEASE AND DESIST ORDER ENTERED AGAINST LAWRENCE ARTZ, NEUROTECH DEVELOPMENT CORP., ENHANCE RESOURCES, INC. AND BRUCE LYNCH

On December 11, the Commission entered an Order Making Findings and Imposing Cease and Desist Order (Order) against Lawrence M. Artz (Artz), Neurotech Development Corp. (Neurotech), Enhance Resources, Inc. (Enhance) and Bruce W. Lynch (Lynch). Artz resides in Dix Hills, New York and Neurotech is located in Manhasset, New York. Enhance is located, and Lynch resides in Brookline, Massachusetts.

The Order finds that between June and December 1998, Artz, Neurotech, Lynch and Enhance offered \$75 million of unregistered notes on two Internet websites. The proceeds of the notes were to be used to finance the sale of prefabricated hospitals in Turkey. In offering the notes, Artz and Lynch negligently misrepresented that Neurotech had orders for five hospitals and that three Turkish banks had expressed a willingness to guarantee the notes, when in fact there were neither orders nor guarantees. No exemptions from registration under the securities laws were applicable to the notes once offered on the Internet.

Without admitting or denying the findings, Artz, Neurotech, Enhance and Lynch consented to the entry of the Order which would (1) find that they violated Sections 5(c) and 17(a)(3) of the Securities Act of 1933, and (2) order them to cease and desist from committing or causing any violation and any future violation of Sections 5(c) and 17(a)(3) of the Securities Act. INVESTMENT COMPANY ACT RELEASES

STRATEVEST FUNDS, ET AL.

A notice has been issued giving interested persons until December 28 to request a hearing on an application filed by Stratevest Funds, et al., for an order exempting applicants from Section 17(a) of the Investment Company Act. The order would permit two series of the Stratevest Funds to acquire all of the assets, subject to the liabilities, of two series of the Forum Funds. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. The notice was originally issued on November 28, 2000 (Investment Company Act Release No. 24751), giving interested persons until December 20, 2000, to request a hearing. However, the original notice was not published in the Federal <u>Register</u>, therefore, interested persons have until December 28, 2000, to request a hearing on the application. (Rel. HOLDING COMPANY ACT RELEASES

GPU, INC.

An order has been issued authorizing GPU, Inc., a registered public utility holding company, to extend to December 31, 2005, the time during which it may issue and sell the 250,000 authorized but unissued or previously reacquired shares of common stock under the GPU, Inc. and Subsidiary System Companies Employee Savings Plan for Nonbargaining Employees and the Employee Savings Plan for Bargaining Unit Employees for each of GPU's electric utility subsidiaries, Jersey Central Power & Light Company, Metropolitan Edison Company and Pennsylvania Electric Company. Directors' Deferred Compensation Plan; (5) the Cinergy Corp. Long-Term Incentive Compensation Plan; (6) the Cinergy Corp. Union Employees' 401(k) Plan; (7) the Cinergy Corp. Union Employees' Savings Incentive Plan; and (8) the Cinergy Corp. Non-Union Employees' 401(k) Plan. (Rel. 35-27295)
