COMMISSION ANNOUNCEMENTS

INVESTORS TOWN MEETING IN INDIANAPOLIS CANCELED

The Investors Town Meeting in Indianapolis scheduled for tonight, December 18, 2000, has been canceled due to inclement weather. At this time no information is available as to rescheduling of the meeting. (Press Rel. 2000-187)

FEE RATE ADVISORY #11

The Congress has passed and the President has received the fiscal 2001 Commerce, Justice, State, and related agencies appropriations bill that will fund the SEC. The bill has not yet been signed, but is expected to be signed no later than Thursday. Effective 12:01 a.m. EST the day the bill is signed, the fee rate on filings made pursuant to Section 6(b) of the Securities Act of 1933 will decrease to \$250 per \$1,000,000, or .00025 of the aggregate offering amount. The current fee rate of \$264 per \$1,000,000 is in effect until the day the bill is signed.

ENFORCEMENT PROCEEDINGS

DAVID LEWIS SENTENCED TO 46 MONTHS IMPRISONMENT FOR OIL AND GAS BOILER ROOM SCHEME

The Commission announced that on December 8 David Shane Lewis was sentenced by U.S. District Judge Barbara M.G. Lynn in Dallas, Texas, to concurrent terms of 46

months imprisonment, ordered to make restitution of \$2,228,171, placed on supervised release for three years to be served at the end of his term of imprisonment, and ordered to pay a \$200 special assessment. (United States v. David Shane Lewis, 3:00-CR-064-M and 1:00-CR-016-C (USDC/NDTX). Lewis earlier had pleaded guilty to one count of securities fraud in connection with several oil and gas offerings by Spartan Oil Corporation (Spartan) and to one count of conspiracy to commit mail fraud in connection with an oil and gas offering by Centurion Group, Inc.

On January 30, 2000, the Commission filed a related civil action alleging that Lewis and Spartan, using a boiler room sales force, made numerous material misrepresentations and omissions in connection with a succession of fraudulent oil and gas offerings and had misapplied investor funds. The Commission action continues. Information derived from the SEC investigation was used by the FBI and the United States Attorney in its development of its case against Lewis. [U.S. v. David Shane Lewis; 3:00-CR-064-M and 1:00-CR-016-C, USDC/NDTX] (LR-16830)

ALAN GIBBONS ENJOINED FOR MISAPPROPRIATING INVESTOR FUNDS

On December 14, an injunctive Order was entered settling a misappropriation of funds case filed by the U.S. Securities and Exchange Commission against Alan C. Gibbons, resident of Chicago, Illinois. Under the settlement, Gibbons is enjoined from violating antifraud provisions of the federal securities laws, and must pay disgorgement in the amount of \$172,000, the payment of which is waived based on Gibbons' demonstrated inability to pay. Gibbons consented to the entry of the Order without admitting or denying the allegations in the complaint.

The complaint alleges that between September 1995 and March 1999, Gibbons, a recidivist securities laws violator, offered and sold approximately \$172,000 in stock and promissory notes issued by companies he formed and owned. The Complaint alleges that Gibbons told investors their funds would be used for his companies. However, Gibbons used the funds for personal expenses. The complaint alleges that Gibbons materially misrepresented to investors the use, safety, liquidity, and returns on the investments. Gibbons told investors that the investments were risk-free, guaranteed, and would produce large returns. For example, Gibbons told some investors that they would receive a return of 5% per month on their investments. However, Gibbons' companies conducted little or no business, lacked a guarantor, lacked sufficient liquid assets to pay the investors, and the investors received no returns on their investments. [SEC v. Gibbons, Civil Action No. 2247, N.D. Ill.] (LR-16831)

INVESTMENT COMPANY ACT RELEASES

NEUBERGER BERMAN EQUITY FUNDS, ET AL.

An order has been issued on an application filed by Neuberger Berman Equity Funds, et al., exempting applicants from Section 17(a) of the Investment Company Act. The order

permits the series of certain registered open-end management investment companies to acquire all of the assets and stated liabilities of the series of certain other registered openend management investment companies. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-24791 – December 15)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The Commission published for comment a proposed rule change (SR-PCX-00-21) filed by the <u>Pacific Exchange</u> relating to financial arrangements of options floor members. Publication is expected in the <u>Federal Register</u> during the week of December 18. (Rel. 34-43714)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change and Amendment Nos. 1 and 2 thereto submitted by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-00-54) to permit the listing and trading, or the trading pursuant to unlisted trading privileges (UTP), of Trust Shares. Publication of the notice in the <u>Federal Register</u> is expected during the week of December 18. (Rel. 34-43717)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-00-36) applying options position reporting requirements and exercise limits to trades with non-member brokers and dealers. (Rel. 34-43718)

The Commission approved a proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-00-32) relating to Rule 748, Supervision. Publication of the order is expected in the <u>Federal Register</u> during the week of December 18. (Rel. 34-43721)
