COMMISSION ANNOUNCEMENTS

U.S. SECURITIES AND
EXCHANGE COMMISSION

ORDER DENYING REQUEST FOR CONFIDENTIAL TREATMENT

The General Counsel sent a letter to Joseph D. Carney affirming the Freedom of Information Act Officer's determination to deny a request for confidential treatment for testimony given by two of the defendants in SEC v. Martin Lewis, et al., Civ. No. 86-2116 (D.D.C. 1986). The General Counsel determined that the testimony (excluding a small number of redactions) was not protected by FOIA Exemptions 6 and 7(C), 5 USC 552(b)(6) and (b)(7)(C). (Rel. FOIA-82)

ORDER DENYING APPEAL

The General Counsel sent a letter to Warren A. Oddo affirming the Freedom of Information Act Officer's determination to withhold evidence supporting the allegation in a Commission complaint that First Jersey Securities, Inc., a registered broker-dealer, was concurrently advising customers to sell securities in some branches, and to buy them in others, filed in pending litigation, SEC v. First Jersey Securities, Inc. and Robert F. Brennan, No. 85 Civ. 8585 (RO) (SDNY). The General Counsel affirmed the assertion of FOIA Exemption 7(A), 5 USC 552(b)(7)(A) and 17 CFR 200.80(b)(A), and also found that portions of the requested evidence should be withheld pursuant to FOIA Exemption 5, 5 USC 552(B)(5) and 17 CFR 200.80(b)(5), and FOIA Exemption 7(C), 5 USC 552(B)(7)(C) and 17 CFR 200.80(b)(7)(C). ORDER UPHOLDING FOIA OFFICER'S DETERMINATION TO WITHHOLD ACCESS TO REQUESTED INFORMATION

The General Counsel sent a letter to Thomas D. Powell affirming the Freedom of Information Act Officer's determination to deny access to "all information" maintained in the Commission's files "concerning anything to do with illegal drugs or the monies derived from illegal drugs used in any type of connection with public offered companies." The General Counsel determined that access should be denied because Mr. Powell's request failed to "reasonably describe" the records sought as required by Section 552(a)(3)(A) of the FOIA and 17 CFR 200.80(a)(3)(A). ADMINISTRATIVE PROCEEDINGS

DATE SET FOR SUSPENSION OF OWEN V. KANE

In November 1986, the Commission suspended Owen V. Kane, of Minneapolis, from association with any broker or dealer for six months. The sanction was based on findings that Kane was responsible for the unlawful sale by A. G. Becker, Inc. of unregistered common stock of Grandma Lee's Inc.

Kane's suspension was stayed pending appeal. The Court of Appeals for the Eighth Circuit recently affirmed the Commission's order. The Commission accordingly made Kane's suspension effective as of April 25, 1988. (Rel. 34-25591)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change that became effective upon filing under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal (SR-NASD-88-14) amends the Resolution of the NASD Board of Governors concerning notice to the membership and the press of certain disciplinary actions permitting the NASD to release to the public certain employment and disciplinary information about members and their associated persons contained in the Central Registration Depository. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
