ADMINISTRATIVE PROCEEDINGS

POWELL SECURITIES, INC. AND FRANK H. POWELL SANCTIONED

The Commission has suspended Powell Securities, Inc., of Coral Gables, Florida, for 30 days, provided that thereafter Powell Securities, Inc. withdraw its registration as a broker-dealer. It has also suspended Frank H. Powell, its president, from being associated with any broker or dealer for 30 days and has prohibited Frank H. Powell from being associated in a supervisory capacity with any broker or dealer for two The sanctions were based on findings that respondents violated the rules under the Exchange Act relating to standards for underwriting a public distribution of an affiliate's securities, disclosure of control by the issuer, net capital, books and records, customer information, fidelity bond, and confirmation requirements and that respondents failed to supervise. The Commission's action was taken pursuant to an offer of settlement in which the respondents, without admitting or denying the allegations in the order for proceedings, consented to the above findings and sanctions. COURT ENFORCEMENT ACTIONS

IRA INGERMAN PLEADS GUILTY AND IS SENTENCED

The Washington Regional Office and Philadelphia Branch Office announced that on March 10 Ira Ingerman, a resident of Narberth, Pennsylvania, and the president of Magic Marker Corporation, was sentenced by the Honorable John P. Fullam, U.S. District Judge, to one year's probation and fined \$1,000 after pleading guilty on February 8 in the U.S. District Court for the Eastern District of Pennsylvania to a one-count information filed on February 1 charging him with filing a false federal income tax return for the year 1972. At the same time, pursuant to the government's motion, the Court dismissed a 31-count indictment brought against Ingerman in September 1977 that had charged him and 13 others with manipulation of the stock of Magic Marker Corporation in 1971-1972. The charges contained in the information arose in part from various 1972 security trades by Ingerman, including one transaction in Magic Marker stock. (U.S. v. Ingerman, E.D. Pa., Criminal Action No. 78-26). (LR-8382)

MICHAEL D. YORDON AND SUSAN E. SMITH PLEAD GUILTY

The New York Regional Office announced that on April 7 Michael D. Yordon and Susan E. Smith each pleaded guilty to one count in satisfaction of three counts of an indictment originally returned on March 2. The subject count charged them with conspiracy to provide false and misleading information to the Commission and a federal grand jury in an effort to obstruct an investigation into the securities of Dimensional Entertainment Corporation.

In a related civil action filed on October 31, 1977, the Commission is presently seeking to enjoin Yordon and Smith from further violations of the registration and antifraud provisions of the securities laws in their transactions in Dimensional common stock. (U.S. v. Michael D. Yordon and Susan E. Smith, 78 Crim. 141, LFM). (LR-8383)

ROBERT J. MAIETTA PLEADS GUILTY

The New York Regional Office announced that on March 28 Robert J. Maietta pleaded guilty to a two count information charging him with perjury during a SEC investigation into the securities of Dimensional Entertainment Corporation. Specifically, the information charged that Maietta perjured himself in sworn testimony before the Commission's staff with regard to his purchases of Dimensional stock through nominee or shared purchases, and the manner in which a third person sold shares of that corporation's stock.

In a related civil action filed on October 31, 1977, the Commission is presently seeking injunctive and ancillary relief against Maietta. (U.S. v. Robert J. Maietta, 78 Crim. 208, LFM). (LR-8384)

COMPLAINT NAMES JOHN T. SMITH

The Denver Regional Office announced that on April 12 the Saunders County Attorney (Nebraska) filed a criminal complaint against John T. Smith, Schuyler, Nebraska, charging him with eight counts of violating the Nebraska securities laws and one count of obtaining money under false pretenses. Arraignment of Smith was on April 17. The Denver Regional Office rendered assistance to the Nebraska Bureau of Securities in bringing this complaint which resulted from a joint investigation of Smith's offers and sales of oil and gas interests in the Nellie Lane 1 and 2 wells in Morrill County, Nebraska and the Moye well in Converse County, Wyoming to investors in Nebraska, Colorado, and other states. On September 3, 1976 the Commission filed a civil complaint against Smith and others in the Federal District Court in Omaha (SEC v. Frank J. Kirby, et al., U.S.D.C. Neb., Civil Action No. 76-0-339). On December 17, 1976, without admitting or denying the allegations in the complaint, Smith consented to the entry of a permanent injunction enjoining him from violating certain provisions of the registration and antifraud provisions of the securities laws in the offer and sale of any security. (State of Nebraska v. John T. Smith, County Court of Saunders County, Nebraska). (LR-8385)

INVESTMENT COMPANY ACT RELEASES

ADMIRALTY FUND PLANS FOR ADMIRALTY FUND GROWTH SERIES

An order has been issued on an application of Admiralty Investment Plans for the Accumulation of Shares of Admiralty Fund, Growth Series, and Admiralty Investment Plans for the Accumulation of Shares of Admiralty Fund, Insurance Series, declaring that they have ceased to be investment companies. (Rel. IC-10217 - Apr. 25)

HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until May 18 to request a hearing on a proposal of General Public Utilities Corporation (GPU), a registered holding company, and its subsidiary, GPU Service Corporation (Service Company), that Service Company borrow up to \$13 million from banks and that GPU guarantee the payment of such indebtedness. (Rel. 35-20513 - Apr. 21)

CENTRAL AND SOUTH WEST CORPORATION

A supplemental order has been issued authorizing a proposal of Central and South West Corporation, a registered holding company, that the period within which it may issue and sell common stock pursuant to its dividend reinvestment and stock purchase plan be extended until April 30, 1980. (Rel. 35-20514 - Apr. 21)

OHIO POWER COMPANY

An order has been issued approving proposals of Ohio Power Company, subsidiary of American Electric Power Company, Inc., and Southern Ohio Coal Company (SOhio), subsidiary of Ohio. The order authorizes a transfer of Ohio's investment in certain coal mining development and associated facilities to SOhio in return for the latter's cash and long-term debt notes. Ohio will also make capital contributions in connection therewith. (Rel. 35-20515 - Apr. 21)

AMERICAN ELECTRIC POWER COMPANY

An order has been issued authorizing American Electric Power Company, Inc., a registered holding company, to adopt a Restated Certificate of Incorporation and to issue and sell shares of its common stock to its Employees Saving Plan. AEP has also been granted an exemption from competitive bidding in connection therewith. (Rel. 35-20516 - Apr. 25)

SELF-REGULATORY ORGANIZATIONS

NOTICE OF PROPOSED RULE CHANGE

The New York Stock Exchange, Inc. has filed a proposed rule change under Rule 19b-4 (SR-NYSE-78-17) to make necessary modifications to its constitution and rules for the implementation and operation of an Intermarket Trading System (ITS), linking the participants (and such other markets as may in the future agree to participate in the ITS) and providing facilities and procedures for (a) display of composite quotation information on the floors of each of the participating exchanges (at the designated trading post) so that members of each participating exchange will be able to determine readily the best bid and offer for a particular multiply-traded security available from any participant, (b) rapid and efficient routing of orders and administrative messages between and among the participants, and (c) participation, under certain conditions, by all participants in opening transactions in the primary market. Publication of the proposal is expected to be made in the Federal Register during the week of April 24. (Rel. 34-14701)

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the Chicago Board Options Exchange, Inc. The rule change (SR-CBOE-78-5) provides a means by which CBOE members may lease their Exchange memberships to qualified broker-dealers. (Rel. 34-14703)
