TRADING SUSPENSIONS

U.S. SECURITIES AND EXCHANGE COMMISSION

TRADING SUSPENDED IN SOURCE INVESTMENT, INC.

The SEC announced the single ten-day suspension of exchange and over-the-counter trading in the securities of Source Investment, Inc., a Utah corporation located in Encino, California, for the period beginning on December 15 and terminating at mid-night (EST) on December 24, 1978. The Commission suspended trading because of questions concerning recent unusual market activity and because of the lack of publicly available information concerning the company's business and financial status, including the ownership of the company's outstanding shares. CIVIL PROCEEDINGS

MCDONNELL DOUGLAS CORP. ENJOINED

The SEC announced that on December 14 a civil injunctive action was filed in the U.S. District Court for the District of Columbia seeking to enjoin McDonnell Douglas Corp. (MDC) from further violations of the antifraud, reporting and proxy provisions of the Securities Exchange Act of 1934 and various rules thereunder.

A judgment of permanent injunction, which was consented to by MDC, without admitting or denying the allegations in the complaint, was entered on December 15 by Judge Aubrey Robinson, Jr. MDC has filed with the Commission a report on Form 8-K which describes in greater detail certain of the transactions referred to in the complaint. In addition, MDC agreed to establish a special review committee to review the adequacy and accuracy of the disclosures contained in the Form 8-K Report and investigate further certain matters alleged in the complaint.

The complaint alleges, among other things, that since about 1969 MDC engaged in an undisclosed course of business whereby in connection with the procurement and/or maintenance of its foreign business it made: (1) payments of approximately \$4.6 million to government officials and officials of government owned airlines; (2) payments of approximately \$3.7 billion to airline officials; and (3) commission payments of approximately \$7.3 million which were made without accounting procedures and controls sufficient to ensure that such payments were actually made for the purpose indicated and that services rendered were commensurate with amounts paid. In addition, the complaint alleged that since at least 1969, MDC utilized commission and consultant contracts designed to facilitate the payment of money into accounts maintained by persons outside their home countries in order to, among other things, facilitate the avoidance of tax and currency control laws of their home countries. PENNSYLVANIA ELECTRIC COMPANY

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the National Association of Securities Dealers, Inc. (SR-NASD-77-21) amending Sections 6 and 19 of the NASD's Code of Procedure for Handling Trade Practice Complaints to require NASD District Business Conduct Committees to give members notice of complaints filed against associated persons and advise members of the final disposition of those complaints.
