UNLISTED TRADING PRIVILEGES SOUGHT. The SEC has issued orders under the Securities Exchange Act of 1934 (Release 34-7859) giving interested persons until April 25 to request a hearing on exchange applications for unlisted trading privileges, as follows: Boston Stock Exchange, in shares of General Precision Equipment Corp., Hercules Powder Company, Interstate Department Stores, Inc., Massey-Ferguson Limited, Minerals & Chemical Philipp Corp., Sanders Associates, Inc., The Singer Company and Warner-Lambert Pharmaceutical Company. Cincinnati Stock Exchange, in shares of Bendix Corp; and Philadelphia-Baltimore-Washington Stock Exchange, in shares of National Video Corp. and Associated Transport Inc.

<u>DELISTING GRANTED</u>. The SEC has granted an application of the New York Stock Exchange to delist the common stock of United Board & Carton Corp. The Stock is now listed on the American Stock Exchange (Release 34-7859).

<u>DUNFEE SAVINGS HEARING SCHEDULED</u>. On request of Thomas Dunfee, d/b/a Dunfee Savings & Lease, <u>Kansas City</u>, <u>Mo.</u>, the SEC has scheduled a hearing for May 2 in the Federal Office Building in Kansas City, on the question whether to vacate or make permanent its February 17 order suspending a Regulation A exemption from Securities Act registration with respect to an offering of securities by Dunfee.

SONIC OIL RECOVERY HEARING SCHEDULED. On request of Sonic Oil Recovery Company, Inc., Dallas, the SEC has scheduled a hearing for May 16 in the U. S. Courthouse in Fort Worth, on the question whether to vacate or make permanent its March 3 order suspending a Regulation A exemption from Securities Act registration with respect to a stock offering by Sonic Oil.

JAMESTOWN TELEPHONE HEARING POSTPONED. Upon request of counsel for Jamestown Telephone Corporation, Meadville Telephone Company and Home Telephone Company of Ridgeway, the SEC has postponed from April 13 to May 16 the hearing on applications of those companies for exemption from the registration provisions of Section 12(g) of the Securities Exchange Act. In requesting the postponement, counsel indicated that discussions with the Commission's staff might lead to a settlement "which would avoid the necessity of a hearing."
