#### INVESTMENT COMPANY ACT RELEASES

# FRANK RUSSELL INVESTMENT COMPANY, ET AL.

An order has been issued on an application filed by Frank Russell Investment Company, et al. permitting certain funds relying on Section 12(d)(1)(G) of the Investment Company Act to enter into a special servicing agreement. (Rel. IC-23676 - February 2)

#### ENDEAVOR SERIES TRUST, ET AL.

A notice has been issued giving interested persons until March 1, 1999, to request a hearing on an application filed by Endeavor Series Trust (Trust) and Endeavor Management Co. (together, Applicants). Applicants seek an order pursuant to Section 6(c) of the Investment Company Act for exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder to the extent necessary to permit shares of the Trust or any other current or future series of the Trust for which Endeavor Management Co. or any of its affiliates may serve as investment adviser, administrator, manager, principal underwriter or sponsor to be sold to and held by: (i) variable annuity and variable life insurance company separate accounts of both affiliated and unaffiliated life insurance companies, and (ii) qualified pension and retirement plans outside the separate account context. # AAL VARIABLE PRODUCT SERIES, INC., ET AL.

A notice has been issued giving interested persons until March 1, 1999, to request a hearing on an application filed by AAL Variable Product Series, Inc. (Fund) and Aid Association for Lutherans (Adviser) (together, Applicants). Applicants seek exemptive relief from Sections 9(a), 13(a), 15(a) and 15(b) of the Investment Company Act and Rules 6e-2(b) (15) and 6e-3(T)(b) (15) thereunder, to the extent necessary to permit certain series of the Fund that are designed to fund insurance products and shares of any other investment company that is designed to fund insurance products and for which the Adviser or any of its affiliates may serve as investment adviser, administrator, manager, principal underwriter, or sponsor to be sold to and held by: (1) separate accounts funding variable annuity and variable life insurance contracts of both

affiliated and unaffiliated life insurance companies; and (2) qualified pension and retirement plans. (Rel. IC-23678 - February 2)

#### SELF-REGULATORY ORGANIZATIONS

## ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change (SR-CSE-99-01) filed by the <u>Cincinnati Stock Exchange</u> to require member firms to participate in computer system testing designed to prepare for the Year 2000 and to file reports with the CSE regarding Year 2000 testing. Publication of the notice and order is expected in the <u>Federal Register</u> during the week of February 1. (Rel. 34-40982)

The Commission granted accelerated approval to a proposed rule change submitted by the <u>American Stock Exchange</u> (SR-Amex-98-38) to eliminate position and exercise limits on a two-year pilot basis for Institutional Index Options and Major Market Index Options and FLEX options on those indexes. (Rel. 34-41011)

#### APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change and issued notice of filing and granted accelerated approval of Amendment No. 1 thereto submitted by the <u>Chicago Board Options Exchange</u> (SR-CBOE-98-49) to provide for the listing and trading of options on the Dow Jones Equity Real Estate Investment Trust Index. (Rel. 34-41009)

#### PROPOSED RULE CHANGE

A proposed rule change has been filed by the <u>American Stock Exchange</u> (SR-Amex-99-01) relating to reductions in the Airline, Natural Gas, Pharmaceutical and Securities Broker Dealer Indices Values. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 8. (Rel. 34-41010)

## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-99-03) to eliminate the aggregation presumption for SOES orders entered within five minutes of each other has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 8. (Rel. 34-41015)
