INVESTMENT COMPANY ACT RELEASES

PRUDENTIAL SERIES FUND, INC., ET AL.

A notice has been issued giving interested persons until March 1, 1999, to request a hearing on an application filed by Prudential Series Fund, Inc. (Fund) and Prudential Insurance Company of America (Prudential). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder to the extent necessary to permit shares of any current or future series of the Fund and shares of any other investment company that is designed to fund variable insurance products and for which Prudential, or any of its affiliates, may serve now or in the future as manager, investment adviser, administrator, principal underwriter or sponsor, to be sold to, and held by: (1) separate accounts funding variable annuity and life insurance contracts of both affiliated unaffiliated life insurance companies; and (2) qualified pension and retirement plans outside of the separate account context. SALOMON SMITH BARNEY INC.

A notice has been issued giving interested persons until March 1, 1999, to request a hearing on an application by Salomon Smith Barney Inc. (Salomon Smith Barney) to amend a prior order. The prior order exempts DECS Trusts and certain future trusts for which Salomon Brothers Inc (Salomon Brothers) serves as a principal underwriter (collectively, Trusts) from Section 12(d)(1) and Section 14(a) of the Act and Salomon Brothers and the Trusts from Section 17(a) of the Act. The requested amendment would extend the relief granted in the prior order to Salomon Smith Barney, a successor entity resulting from the merger of Smith Barney Inc. (Smith Barney) and Salomon Brothers, and any DECS Trust or other substantially similar trust for which Smith Barney or Salomon Smith Barney has served or will serve as principal underwriter. (Rel.
