ENFORCEMENT PROCEEDINGS

COMMISSION FREEZES TRADING PROFITS OF OFFSHORE COMPANY IN ALLEGED UNREGISTERED PUBLIC OFFERING OF MICROCAP ISSUERS

The Commission today announced that on February 17 it filed a civil action against Glittergrove Investments, Ltd., an Irish corporation with addresses in Dublin, the Isle of Jersey and the Isle of Man, Glittergrove that participated in unregistered distributions of the common stock of two companies: Citron, Inc. and Electronic Transfer Associates, Inc. The Honorable Sidney H. Stein, United States District Judge, Southern District of New York, issued a temporary restraining order barring Glittergrove's future violations of the registration provisions and temporarily freezing at least \$2.5 million in proceeds from sales of Citron and ETA made in violation of the registration provisions of the federal The Court scheduled a hearing for March 1, 1999, securities laws. on the Commission's motion for a preliminary injunction. In its action, the Commission is also seeking permanent injunctive relief, disgorgement of illegal proceeds with prejudgment interest, and civil money penalties based upon violations of Sections 5(a) and 5(c) of the Securities Act of 1933.

The Commission's complaint alleges that a group made up of defendant Glittergrove and seven other offshore entities, represented by Peter C. Tosto (now known as Peter Lybrand), acquired shares representing the bulk of the outstanding common stock of Citron and ETA. These common shares, acquired from founding shareholders and groups of their friends, family and business associates, were resold in open market transactions by Glittergrove and certain other offshore entities when no registration statement was in effect. In documents filed in support of the emergency relief, the Commission noted that, of the \$2.9 million in illegal sales proceeds that once resided in Glittergrove's U.S. brokerage accounts, roughly \$350,000 had already been expatriated, and that Glittergrove planned to transfer the remaining \$2.5 million outside of the United States yesterday. GRADY SANDERS ORDERED TO PAY \$1,115,195 IN MICROCAP FRAUD CASE

On February 2, the Commission obtained a federal court order requiring Grady A. Sanders of Los Angeles to pay \$1,115,195 in

penalties and disgorgement arising from Sander's fraudulent promotion of a microcap company. The order, entered by the Honorable Louis F. Oberdorfer of the United States District Court for the District of Columbia, enforces payment of penalties and disgorgement previously imposed by the Commission in an administrative proceeding. Sanders consented to the entry of the District Court's order. The Commission filed its complaint, pursuant to Section 21(e) of the Securities Exchange Act of 1934 (Exchange Act) [15 U.S.C. ° 78u(e)], on September 30, 1998. The complaint charged that Sanders failed to comply with the terms of the prior Commission order imposing remedial sanctions issued in In the Matter of New Allied Development Corp., Erica J. Hull, and Grady A. Sanders, Administrative Proceeding File No. 3-8395 (November 26, 1996).

The prior Commission order contained findings that Sanders and another respondent were responsible for material omissions and fraudulent representations concerning a microcap company's, New Allied Development Corp. (New Allied), disclosure statements, made pursuant to Exchange Act Rule 15c2-11, and press releases and concluded that Sanders and the other respondent violated the antifraud provisions of the Securities Act of 1933 (Securities Act) and the Exchange Act, and of Rule 10b-5 thereunder. The Commission imposed remedial sanctions on Sanders and required him to pay disgorgement of \$115,195, prejudgment interest on the disgorgement amount, and a civil money penalty of \$1,000,000. After Sanders failed to pay the disgorgement and penalty as ordered by the Commission, the Commission initiated this action. [SEC v. Grady A. Sanders and Erica J. SEC FILES ACTION AGAINST NORSUL OIL & MINING, LTD AND WAYNE FOWLER FOR FAILURE TO COMPLY WITH A COMMISSION ORDER

On February 17, the Commission filed a complaint in the United States District Court for the District of Columbia against Norsul Oil & Mining, LTD. and Wayne E. Fowler alleging that Norsul, a Marietta, Georgia-based company, and Fowler, Norsul's president and chief operating officer, have failed to comply with a Commission order issued on August 7, 1996 (In the Matter of Norsul Oil & Mining, LTD. and Wayne E. Fowler, 62 SEC Docket 249) (Commission Order). The Commission Order found that Norsul had failed to file an Annual Report on Form 10-K for four years (1990, 1992-94), as well as numerous Quarterly Reports on Form 10-Q, and had not filed audited financial statements with its Annual Report for six fiscal years (1985-91) in violation of Section 13(a) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 12b-25,13a-1, 13a-11 and 13a-13. The Commission Order ordered: (i) Norsul and Fowler to cease and desist from future violations of the reporting provisions of the Exchange Act; (ii) Norsul to retain an accountant within 30 days of the Commission Order becoming final; and (iii) Norsul to take steps to comply with the reporting provision of the Exchange Act within 90 days of the Commission Order becoming final. The complaint alleges that since the Commission Order became final

Norsul and Fowler have made no filings with the Commission, nor have they taken any other actions to comply with the Commission Order. The complaint seeks a court order compelling Norsul and Fowler to comply with the Commission Order and a penalty against Fowler. [SEC v. Norsul Oil & Mining, LTD and Wayne E.
