RULES AND RELATED MATTERS

AMENDMENTS TO RULE 504 OF REGULATION D

The Commission has issued a release adopting amendments to Rule 504, the limited offering exemption under Regulation D. The amendments are designed to deter abuses of this rule yet preserve the ability of legitimate small businesses to raise capital. These amendments would establish the general principle that securities issued in a Rule 504 transaction, just like the other Regulation D exemptions, would be restricted, and would prohibit general solicitation and advertising, unless the specified conditions for a public Rule 504 offering are satisfied. The amendments will be effective 30 days after publication in the Federal Register. AMENDMENTS TO RULE 701 OF THE SECURITIES ACT

The Commission has issued a release adopting amendments to Rule 701 under the Securities Act of 1933, which provides an exemption from registration for securities issued by non-reporting companies pursuant to compensatory arrangements. These amendments make Rule 701 more useful and eliminate unnecessary restrictions by removing the \$5 million aggregate offering price ceiling and setting the maximum amount of securities that may be sold in a 12-month period to a more appropriate limit based upon the size of the issuer. Further, specific disclosure is required if issuers sell more than \$5 million in a 12-month period and the definition of consultant and advisor is harmonized to the one contained in Form S-8, the shortform registration statement form under the Securities Act for the offer and sale of employee benefit plan securities. The amendments to Rule 701 will be effective 30 days after publication in the Federal Register. AMENDMENTS TO SECURITIES ACT FORM S-8 AND RELATED RULES

The Commission has issued a release (Rel. 33-7646) adopting amendments to Form S-8 under the Securities Act of 1933, the short-form registration statement for offers and sales of a public company's securities to its employees, and related rules. Some of

the amendments are designed to deter misuse of this form either to avoid the Securities Act registration requirements that apply to securities sales to non-employees or to issue securities as compensation to stock promoters. Other amendments permit employees' family members to use Form S-8 to exercise options issued under employee benefit plans. These amendments are designed to facilitate intra-family transfers of options for estate planning purposes. The Commission also has issued a release (Rel. 33-7647) proposing additional amendments to Form S-8 that also are designed to deter misuse of the form, and extending the comment period on some of the amendments to Form S-8 that were proposed in Release 33-7506. ENFORCEMENT PROCEEDINGS

FINAL JUDGMENT OBTAINED AGAINST JOEL FEIN, TIMOTHY HAZZARD, MARK McCLAFFERTY AND GRACE NA

On December 31, 1998, the SEC obtained judgments and substantial penalties against the perpetrators of a telemarketing Ponzi scheme that raised over \$15 million from investors nationwide. Chief Judge Richard P. Matsch of the United States District Court for the District of Colorado issued Final Judgments of Permanent Injunction against Defendants Joel A. Fein, Timothy M. Hazzard, Mark D. McClafferty and Grace Na. The Final Judgments enjoin Fein, Hazzard and McClafferty from violations of Section 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The Final Judgment as to Na enjoins her from violations of Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. In addition, the Final Judgments order: (1) Fein to disgorge \$1,074,945 plus prejudgment interest and pay a \$500,000 penalty; (2) Hazzard to disgorge \$1,143,220 plus prejudgment interest and pay a \$500,000 penalty; (3) McClafferty to disgorge \$2,644,198 plus prejudgment interest and pay a \$750,000 penalty; and (4) Na to disgorge \$396,909 plus prejudgment interest and pay a \$100,000 penalty. Also named in the complaint as defendants were Commercial Express, LLC and Progressive Financial, Inc., both operating in Santa Monica, California, as well as six other entities and individuals. action against these defendants is pending. SEC OBTAINS FINAL JUDGMENTS CONCLUDING FUTREX SECURITIES FRAUD CASE

The Commission has obtained a final judgment against Futrex, Inc., Futrex Medical Instrumentation, Inc. (Jointly referred to as "Futrex"), and Robert D. Rosenthal, Futrex's chairman of the board, chief executive officer, president, and treasurer, in a fraud case

arising from Futrex's private placement of securities in 1994 and abortive initial public offering in 1995. Without admitting or denying the Commission's allegations, the defendants consented to entry of the judgment, which enjoins them from violating Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder, and orders Rosenthal to pay a \$50,000 civil penalty.

The Commission's complaint, filed on September 23, 1996, alleged that the defendants, in connection with Futrex's 1994 private placement and 1995 abortive initial public offering, made materially false and misleading statements concerning Futrex's "Dream Beam" product, a hand-held laboratory instrument that purportedly could measure a person's blood glucose level by passing infrared light through his or her finger. Among other things, the complaint alleged that the defendants fraudulently made unsupportable claims about the effectiveness of the Dream Beam, and staged deceptive demonstrations of the Dream Beam for prospective investors.
