ENFORCEMENT PROCEEDINGS

RUSSO SECURITIES, INC., PATRICK RUSSO, AND KIMBERLY KENT

On March 2, an administrative law judge issued an Initial Decision in the Matter of Russo Securities, Inc., Partick Russo, and Kimberly Kent. The law judge concluded that Respondent Russo Securities, Inc. violated Section 15(c)(3) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 15c3-1 thereunder, the Commission's net capital rule, in that it executed customer transactions on December 29, 1995, and January 31, February 29, and March 22, 1996, while it did not have a minimum of \$100,000 of net capital. The law judge further concluded that Russo Securities, Inc. violated Section 17(a)(1) of the Exchange Act and Rules 17a-3, 17a-5, and 17a-11 thereunder, in that its books and records reflecting its net capital computations on the above dates were inaccurate, and that it failed to notify the Commission of its net capital and books and records deficiencies. The law judge further concluded that Patrick Russo and Kimberly Kent aided and abetted and caused the above violations.

The law judge ordered Russo Securities, Inc. to pay a civil penalty of \$100,000, and Patrick Russo and Kimberly Kent to each pay \$25,000 in penalties. The law judge barred Patrick Russo from being associated with a broker-dealer, and from being associated with a member of a national securities exchange or registered securities association, with a right to reapply after two years. Kimberly Kent was suspended from being associated with a broker-dealer, and from being associated with a member of a national securities exchange or registered securities association for one year. The law judge also ordered Respondents to cease and desist from committing or causing any violations or future violations of the Sections and Rules listed above. SEC FILES INSIDER TRADING ACTION AGAINST STEVAN BIRNBAUM

The Commission filed an injunctive action against Stevan A. Birnbaum in the U.S. District Court for the Central District of California. The complaint alleges that Birnbaum engaged in insider trading in advance of a July 1995 announcement that Sandoz, Ltd. was making a cash tender offer for the securities of Genetic Therapy, Inc. Without admitting or denying the allegations of the complaint, Birnbaum consented to the entry of a final judgment permanently enjoining him from violating Sections 10(b) and 14(e) of the

Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 thereunder. The final judgment requires Birnbaum to pay a total of \$307,720, including disgorgement, prejudgment interest and a civil penalty.

The complaint alleges that when Sandoz and GTI were engaged in nonpublic preliminary merger negotiations, Birnbaum received material nonpublic information regarding the negotiations from a GTI board member on a confidential basis. Between May 30, 1995 and July 7, 1995, only days before the public announcement of Sandoz's tender offer for GTI's securities, Birnbaum purchased GTI stock for his personal account, and in his children's trust accounts. Birnbaum received unlawful trading profits of \$83,528 for these transactions. In addition, Birnbaum recommended GTI to his fiancee and a private investment partnership in which Birnbaum held a 8.5% interest. Birnbaum's recommendations resulted in profits of \$92,548. In settling this matter, Birnbaum has agreed to disgorge his own profits, the profits of his fiancee and the partnership, and to pay prejudgment interest of \$48,116 and a civil penalty of \$83,528. COMPLAINT FILED AGAINST LYNNE MERCER

On March 2, the Commission filed an action charging a Bountiful, Utah, accountant with forging the signature of his former partner on audit opinions for three publicly-held companies. The Commission alleges that Lynne K. Mercer (Mercer) purportedly audited the financial statements of Computerized Thermal Imaging, Inc. for fiscal 1993, 1994 and 1995 and the eight-month period ended February 29, 1996, Son-Tech, Inc. for the year ended December 31, 1997, and Technology Selection, Inc. for the year ended June 30, 1998. issuing the audit opinions for these financial statements Mercer signed the name of Ted H. Pierce & Associates, an American Fork, accounting firm, without the firm's knowledge The State of Utah revoked Mercer's license as a authorization. certified public accountant in 1992. The Commission's action, filed in the United States District Court for the District of Utah, seeks preliminary and permanent injunctions against future violations of the antifraud provisions of the Securities Exchange Act of 1934, disgorgement and civil penalties. COMMISSION SEEKS TO COMPEL MEHL BIOPHILE INTERNATIONAL, INC. TO FILE DELINQUENT PERIODIC REPORTS

On March 2, the Commission filed a complaint in the United States District Court for the District of Columbia against Mehl Biophile International, Inc. (Mehl), an issuer whose securities are quoted in the pink sheets. The complaint alleges that Mehl, a company that markets hair removal and cosmetic dermatological products, failed to make available to the investing public current and accurate information about its financial condition and results of operation through the filing of periodic reports with the Commission as

required by the Securities Exchange Act of 1934 (Exchange Act). Specifically, the complaint alleges that Mehl has not filed its Annual Report on Form 10-K for the fiscal year ended May 31, 1998, its Quarterly Reports on Form 10-Q for the fiscal quarters ended August 31 and November 30, 1998 and three Notifications of Late Filing with respect to its delinquent reports. The Commission seeks to compel Mehl to file its delinquent periodic reports and enjoin Mehl from further violations of Section 13(a) of the Exchange Act of 1934 and Rules 12b-25, 13a-1 and 13a-13 thereunder.
