ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS SETTLED AGAINST JOEL HURST AND LARRY MULLER

The Commission has entered an Order Making Findings and Imposing Remedial Sanctions and Cease And Desist Order (Order) against Joel L. Hurst of Magnolia, Texas and Larry E. Muller of The Woodlands, The Commission accepted Hurst's and Muller's Offers of Settlement, in which they agreed to be barred from association with any broker, dealer, municipal securities dealer, investment adviser, or investment company; Hurst and Muller also agreed to orders for them to cease and desist from committing or causing any violations of, and any future violation of, Section 17(a) of the Securities Act 1933, Section 10(b) of the Exchange Act and Rule 10b-5 thereunder, as well as not to cause violations of Sections 15(c) and 17(a) of the Exchange Act and Rules 15c3-1, 17a-3, 17a-5 and 17a-11, thereunder. Additionally, Hurst agreed to pay disgorgement of \$658,822, plus prejudgment interest and Muller agreed to pay disgorgement of \$225,148, plus prejudgment interest. The Commission agreed to waive payment of such amounts and not to impose civil penalties against Hurst and Muller, based on their demonstrated financial inability to pay.

The Order finds that while Hurst and Muller were registered representatives of a registered broker-dealer, they engaged in a parking scheme that resulted in excessive markups, as well as

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE AMENDING EXCHANGE RULE 347

The New York Stock Exchange filed a proposed change (SR-NYSE-99-04) that would amend Exchange Rule 347 to expressly allow employees to bring employment related claims before the Equal Employment Opportunity Commission, National Labor Relations Board, or state or local anti-discrimination agencies. ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the <u>New York Stock Exchange</u> (SR-NYSE-99-05) to use the Interim Forms U-4 and U-5 for the duration of their application as the industry standard.
